Report of the President

Bethany Palumbo, Conservator, Life Collections at the Oxford University Museum of Natural History and also one of our first Fitzgerald Travel Grant recipients; and Rusty Russell, Program Director for Collections and Informatics, United States National Herbarium, Smithsonian Institution. Collectively they bring both fresh ideas and vast experience with collections to the table and we look forward to interacting with both of them. Their three year term begins at the end of this meeting.

Thanks also go to Richard Sabin and Greg Watkins-Colwell, our outgoing Members-at-Large. This year we also lost the long standing services of our secretary Judith Price who retired after many years of dedicated service to the society and its members. She also stepped down as co-chair of our Professional Development Committee after stepping in to assist after the meeting in Cardiff. We thank her for her many years of service. Tim White has also indicated he will be stepping down as co-chair of best practices and our thanks are extended to him. The Society will obviously be looking to fill these vacant positions and we would encourage anyone with an interest in serving us in this capacity to step forward and make themselves known.

A belated thank you to the Local Organizing Committee of the Cardiff meeting. The hard work of Julian Carter and his group was much appreciated. The meeting was a resounding success with a large international contingent broadening our membership base and forging new partnerships in the international collections community. We hope that this will be further cemented at our meeting in Berlin in 2016.

As has become customary in these reports I will address our highlights through the goals of our recently enacted strategic plan. The first goal of this plan is to show leadership in defining and developing the profession of natural history collections care. Once again we are fostering and nurturing the new generation of professionals through the provision of Fitzgerald and Christine Allen travel grants to the annual meeting. This year we have six enthusiastic travel grant awardees who will hopefully follow in the footsteps of previous awardees in becoming active participants in the Society and our recently created Emerging Professionals Committee. The enthusiasm and progress of this group is encouraging and we are very proud of their achievements. They have an active membership who are contributing to their Blog, *Cracking the Collections*, Facebook and Twitter social media streams as well as liaisons providing new perspectives and ideas to each of our standing committees. They have an active presence at this meeting with events for new and old members alike.

We continue to engage the wider community through our website and the NHCOLL-L listserv and have made significant strides in implementing the infrastructure necessary to get our planned best practices wiki up and running. We now have a presence on Biowikifarms that will serve as the basis for best practices content and committee pages to facilitate, engage and inform the collection community of both SPNHC business and best practices in general. Thanks to Tim White, James Macklin and Rachael Arenstein for continuing to work on this important SPNHC product. Information on this resource will hopefully become public very soon.

Late last year we were awarded a 5-year NSF-funded Research Coordination Network (RCN) grant to investigate the building of a sustainable community to implement a Network Integrated Biocollections Alliance (NIBA). This is a collaboration with the Natural Science Collections Alliance (NSCA) and the American Institute of Biological Sciences (AIBS). Although considerable work has already been done by iDigBio in the realm of digitization and access to collections, a lot of work remains to be done. The funding for iDigBio will eventually run dry and the task of this RCN is to investigate ways of sustaining and expanding upon this great start. The RCN's work has already begun with the formation of an Advisory Council who will lead the process and schedule workshops around the key goals of NIBA. An initial meeting of this advisory council was held in Washington, DC in February of this year at which a number of key deliverables were discussed and outlined. You have heard more about these from Rob Gropp during the plenary session of this meeting, including a rebranding of the RCN to avoid confusion over the goals of the initial NIBA report. Building and engaging a large community of stakeholders and interested parties both within and outside our traditional realm is key to the success of this plan and that is where you come in. SPNHC, as a leading partner in this initiative and having within its membership the knowledgeable, dynamic, enthusiastic people who will form the driving forces behind any such plan, will need its members to become fully involved in the process now. Your ideas and views are important and your input is solicited at this early stage. There will be more news in the coming months concerning other initiatives to engage the collections community and the ever growing community of end users of collections data. But, before we can engage these end users we need to better understand our own community and another of our key partners is attempting to do this. The Global Registry of Biodiversity Repositories (GRBio) is facilitating an online registry of authoritative information about all collections. This is a huge undertaking and at a meeting in May of this year, SPNHC was identified as a key partner in this process. I would encourage everyone to take an active role in this growing international effort.

The second goal of the plan is to communicate the activities of the Society to its membership, stakeholders, and the general public. Here again, we have made significant strides. Our transition to digital publication of both Collection Forum and our Newsletter is finally complete and both now provide new and exciting ways of providing this content and engaging our membership. Our agreement with the American Institute of Conservation and the Smithsonian's National Museum of natural History to replace the Storage of Natural History Collections book is at an advanced stage with a signed MoU between the three partners to produce Preventive Conservation: Approaches to Collection Storage (a working title). They have an editorial board in place, have started lining up authors for various chapters and begun the hard work or putting together what promises to be a compelling resource.

Publications are one method of communicating our goals, but there is no better way of doing this than through personal contact. Once again, our committee meetings will be held during the regular meeting to facilitate a more active participation from our membership and I hope a number of you took advantage of that. This year SPNHC will also continue its tradition of co-sponsoring two specialist sessions at the 2015 meeting of the Geological Society of America (GSA) entitled *Using Digitized Data in Geological and Paleontological Research* (organized by Talia Karim and Gil Nelson) and *Specimen-Based Research and the Reality of Paleontological Resource, Specimen and Data Management: Strengthening Partnerships among Federal Land Managers, Repositories, and Researchers* (organized by Kathy Hollis and others) to be held in November of this year in Baltimore, Maryland.

We have also continued building a community of stakeholders in the collections community through active partnerships, and in some cases formal MoUs, with societies and organizations that have common or complimentary goals. This not only has obvious benefits for our NIBA initiative but also ensures collaboration and communication throughout the community toward a common agenda. We are working closely with not only NSCA, AIBS and AIC as mentioned above but also iDigBio, GSA, GCG, NatSCA, ICOM, AAM and many other national and international partners.

The third goal of the plan is to make more efficient use of our financial resources. With our switch to digital publication, our increased membership and wonderful support from vendors and donors, we are on a sound financial footing. Our vendor's assistance in supporting our newsletter and annual meetings is much appreciated. Tim White continues to manage these long-term relationships and their support is vital in providing the society with this financial backing. Many of these sponsors are at this annual meeting and I encourage you to visit their stands and thank them for their support.

The final goal of the plan is to work internationally to further the goals of the Society. Suzanne Ryder, through the Sessional Committee on International Relations, continues to pursue international collaborations and to investigate SPNHC's role in the worldwide community. Through our MoU agreement with GCG and NatSCA, and with input from various EPG members, an initial report has been

drafted and will be presented at the annual meeting. We are also actively engaging members in other parts of the world to find methods by which SPNHC can provide much needed support.

I hope from this brief summary, and the more detailed committee reports that follow, it is evident that SPNHC has been productive on behalf of its members. As is always the case however, the society cannot function without the active involvement of its membership. Our lofty goals can only be achieved through your participation in the running of the society and the activities of its committees. I would encourage all of you to join one or more of our committees, run for office or nominate a colleague.

I thank all of our current council members for their dedicated service and lastly wish to thank the local organizing committee of this meeting, under the leadership of Elise LeCompte, for a wonderful meeting. I wish you all a great year ahead.

Report of the Treasurer

In 2014, the Society's total net assets increased to \$242,613 from a total of \$219,236 the previous year. Liabilities and net assets for 2014 totaled \$269,243. Operating income was generated from three sources: membership dues, advertising in the Newsletter, and publication sales. A total of \$31,060 in membership dues was received. Sales of our six publications plus royalty payments brought in \$9,049. A total of \$3,565 in donations was received.

Sixty-four subscribers and 469 individuals, institutional, corporate and student members renewed their membership for the year 2014. Of the 566 active SPNHC members in 2014, 100 joined for the first time.

Major expenses for the Society in 2014 were \$3,766 for the Christine Allen grant and the Fitzgerald Travel grants, \$3,143 for two issues of the SPNHC Newsletter, \$2,553 for membership booth accessories and transportation to meetings, and \$1,548 to support travel and accommodation for a meeting to discuss the upcoming Storage book.

Additional expenses include \$950 for annual hosting fees for the SPNHC website plus fixes to the website, \$886 for printing extra copies of SPNHC books, \$539 for the online hosting of *Collection Forum* Vol 28 (additional expenses for this publication were paid in 2015), \$421 for the 2014 election, \$377 for Chris Norris to travel to Washington, DC to meet with curators from the Department of the Interior, and \$275 for the annual fee to Cross Ref. The Treasurer's Office incurred the following expenses: \$5,500 for the 2013 financial review, tax preparation and filing, \$3,273 for insurance, and \$453 in merchant fees.

Long-term investment funds were consistent with the market; SPNHC investments saw a market value gain of \$1,392 while the money market account earned \$8,810 in dividends, capital gain distributions and interest. The CD account earned \$58 in interest.

The first part of 2015 has seen good income activity. By March 31, \$30,850 has been received from membership dues, including deferred dues paid in 2014. As of March 31, 2015 we have 554 active members, including Life members.

Membership renewals included 15 student, 319 individual, 56 library/subscriptions, 27 institutional and 6 corporate renewals. As of March 31, 98 new members have joined in 2015, of which 27 are student memberships, 8 are institutional, 1 is library and the remainder are individual. By March 31, 129 members who paid in 2014 had yet to renew for 2015. Please pay your dues on time.

In the first quarter of 2015 sales of all our publications total \$1,042. Additionally, by March 31, we received \$823 in royalties from Copyright Clearance Center. We have received \$170 in unrestricted donations and \$1,431 in restricted donations. A sincere thank you to all.

Expenses incurred in FY2015 as of March 31 include \$17,901 for publishing and printing *Collection Forum* Vol. 28 and the Spring 2015 Newsletter, \$5,000 for to Burdette, Smith & Bish for the 2014 Financial Review, \$570 for reprinting the Storage: Ideas volume, \$500 for membership booth rental at GSA 2015, \$467 for PayPal fees and \$100 for P.O. Box rental. The Society anticipates expenses related to publications, travel grants, updates to the membership database, projects to be undertaken by the Best Practices Committee, the trade show booth and 2015 online election.

Standing Committee Reports

Archives

BACKGROUND

The Smithsonian Institution Archives (SIA) houses the archives of SPNHC. SIA currently holds 16 deposits of SPNHC material totaling 23.5 cubic feet. Examples of this material include *Collection Forum*, SPNHC newsletters, documentation of annual meetings, financial files, election ballots, member-at-large files, various committee files, videos, CDs, and photographs.

PROCEDURE

The committee chair acts as liaison between SIA and SPNHC. The committee receives, lists, and transfers material to the Smithsonian Institution Archives when sufficient quantities accumulate. All material that is deposited within a fiscal year (October 1 through September 30) is assigned the same accession number and housed in the same storage box/unit. Some SPNHC archives need to be rehoused in archival materials prior to transfer to SIA. All material that has been received since the last deposit is being held by the committee.

CURRENT WORK

Although SPNHC is publishing electronically, printed copies of the SPNHC newsletters and Collections Forum are being deposited in SPNHC's archives. No requests for archived information were received by the chair in the past year. Material for deposit was received from Susan Butts in January, and from Judith Price in April 2015. Meghann Toner and/or Linda Hollenberg continue to photo document the SPNHC annual meetings. As per SIA protocols, both electronic and physical materials are being prepared for deposit in SIA.

Best Practices

Last October SPNHC co-hosted a technical session at the Geological Society of America (GSA) with iDigBio and the Paleontological Society. Talia Karim (University of Colorado, Boulder) and Tim White with Gil Nelson (iDigBio) organized the best practices a session Advancing the Digitization of Paleontology and Geoscience Collections: Projects, Programs, and Practices. This is the second co-sponsored session at GSA in four years and there has been considerable interest in best practices in the geological community. Discussions are underway about another session at GSA in 2015 or 2016.

Over the past couple years, interest has been growing amongst a group of museum archivists and collections managers about practice and methods for managing museum archival collections. This spring, Christina Fidler (MVZ), Barbara Mathe (AMNH), Rusty Russell (NMNH) and Tim White are hosting a panel discussion at the annual meeting of the Council for Library and Information Resources, entitled Grinnell to GUIDs: Connecting Natural Science Archives and Specimens. At the Society of American Archivists annual meeting this August, a lightning session entitled A Different Type of Animal? Advocating for Natural Science Archives is on the agenda and looks to bring the museum archivists and collections managers together to discuss challenges with natural history museum archive collections. Discussions are continuing with other professional societies for co-sponsored sessions. If anyone is interested in organizing a "Best Practices Session" at a discipline meeting please touch base with the Best Practices chairs.

James Macklin and Tim White have been working with the SPNHC Web Committee on the development of a SPNHC wiki for the management of information as it relates to committee activities and best practices documentation case studies of specific topical areas. With Council approval, Rachel Arenstein has been contracted to assist with the development and training of the SPNHC wiki over the next two years.

At the end of this annual meeting, Tim White and James Macklin will be stepping down as co-chairs of the Best Practices Committee. If you are interested in filling this important post in the Society please contact President Andy Bentley.

Conference

Conservation

Food service in museums; Team: Rebecca Newberry, Bethany Palumbo and Fran Ritchie
The food service survey was circulated during the spring of 2014, and since then the team has been working
diligently on correlating the 351 responses. Newberry, Palumbo and Ritchie have completed this and written up the
results. They will be presenting results at the American Institute for Conservation annual meeting in Miami, Florida
(May 13-16, 2015) and at the SPNHC annual meeting in Gainesville. The report and data will be published,
although the final disposition has not been decided at this point. Web committee is working on a Wiki site for
sharing best practices, so that would be the logical choice for distribution. Other possibilities for publication will
include the SPNHC newsletter, and Collections Forum. The next steps into making a best practices out of the
results will be discussed at the Conservation Committee meeting in Gainesville. The subcommittee members would

Resource Display Unit; Team: Gretchen Anderson, Lori Benson, Annette Van Aken and Tim White, The challenge with the current units is that they are out of date, bulky and currently being underused. They are of more use to a North American audience at this time. There has been discussion on the need to modernize the

RDU, making it more flexible and more useful for an international audience. Yale has digitized the samples. Lori Benson has been working on consolidating and updating the Canadian and US updating the materials list. Gretchen Anderson brought the RDU to Pittsburgh in March to both display it at a Preservation Fair hosted the Carnegie Museum of Natural History, the Carnegie Library of Pittsburgh, the Hunt Library and other preservation professionals. Anderson is looking more closely at the RDU in order to update materials. During the past year there have been several suggestions on how to make the product more accessible. These include: replacing the current units with a poster, perhaps printable from the web site; creating a small kit with samples, associated with the poster or with the membership booth; a test case for using new Wiki to discuss and add comments. Other suggestions include linking these initiatives with Simon Lambert's storage design helping website being developed at CCI and the AIC/SPNHC initiative STASH which will contain a materials list. Further discussion needs to happen to determine the most advantageous method of dispersal and how to make this resource useful on

a border scale. If you have something to contribute, or would like to be a part of this project, please contact Gretchen

Documentation

Since the 2014 annual meeting, the focus of the Documentation Committee has been focusing on mainly on two "projects/areas."

The first "project/area" is how the Documentation Committee's current scope and duties relates to other SPNHC committees. This effort is attempting to help clarify and redefine how our Committee needs to coordinate, collaborate, and work with other SPNHC Committees (especially Publications, Web, and Best Practices). We are also using this self-analysis to help determine if we need to adjust projects and/or pass any projects to other committees to make the best use of our and SPNHC resources and efforts.

The second "project/area" involves the cleaning of the past citations data of the Citations Subcommittee in order to establish a comprehensive bibliography or database of gathered Natural History related collection care citations available to SPNHC membership and others working with Natural History collections. We hope to have this available on the web in future, but in the meantime, the Subcommittee Chair currently has a comprehensive EndNote library of past citations and is willing to run specific searches upon request (contact Margaret Landis [paleocatstar@ou.edu], if interested).

While it has not been a prime focus this past year, a couple additional "projects/areas" of note are:

- We continue to refine our workflow, including how we are sharing files with each other.
- We continuing to try to keep track of potential documentation needs or areas with unpublished best practices or areas that may have unclear or potentially unclear documentation within the profession of natural history care.

While we continue working on our various "projects/areas," we encourage all SPNHC members to continue to voice potential needs within the profession that are lacking clear or established documentation so we can help work toward rectifying any holes, even if we need to pass the idea to a more appropriate committee as we work towards greater collaboration within SPNHC.

Citations Subcommittee:

The Citations Subcommittee is continuing to gather citations from diverse sources that cover collection management, care of collections, or information potentially relevant to natural history collections care. While the format has changed (and may continue to evolve, this coming year), we still need assistance in gathering those resources, especially as some come from obscure or less read publications. In order to ensure a more global coverage of articles, we are looking for more international contributions and contributors. Including more contributions that are international has been a slow process and there are many missing from our list. Consequently, we kindly request that you share with us any that you are aware of even if you are not one of our regular contributors. We would prefer to receive information about a publication we already know about than miss them. Additionally, we know we have some gaps in coverage; therefore, we welcome information about all natural history care related publications—even those publications that some may consider older or historical publications—as we are trying to have as comprehensive a compilation of total citations as possible.

We are currently looking for contributors and/or assistance in gathering, formatting, and finding the missing publications to the Citations Subcommittee as retirements and changes in jobs or job responsibilities have shrunk our contributors. While we appreciate all they have done and thank them for their assistance over the years, we are also excited to see who will take their place and continue the Citations legacy they have left us. Please contact the Citations Subcommittee chair, Margaret Landis [paleocatstar@ou.edu], with both any citations you encounter as you gather your own collection care/digitization/cataloging-based articles for reference or if you know of anyone who would be a good asset to the membership of the Citations subcommittee.

Positions filled are two Members-at-Large. The successful candidates are:



There were 11 nominations received from 11 different members. 1 of the members nominated declined to stand.

The election started with an email message sent to all members on a 'voting list' (provided to Elections Online based on the Treasurer's most recent membership list as of September 2014). At the close of the election on January 31st 2014, the total number of returned ballots was 259, or 46.5% of the eligible members – an increase of 11.75% from the previous year. The table below outlines the trends over the last 4 elections. This election was the 7th in which members could vote online.

Increase of voters from last year-34.75% to 46.50% (up 11.75%)

Slight increase of eligible voters from 541 to 557

Recently, the EC agreed for the PC to sign a Rightsholders waiver to waive any and all claims of copyright infringement as a result of licensed users creating translations of only works that we enter(ed) into the Annual and Multinational Copyright License repertory. Any translated copies are not authorized hard copies or electronic reproductions, nor may they be used outside the User's organization. These translations are solely for internal business use by CCC licensed business users. In exchange for the waiver, each licensee will be required to provide an indemnity to CCC and all participating Rightsholders with respect to any claims or liabilities arising from the translations or their use.

Sessional Committee Reports

International Relations

At the Cardiff meeting last year we had a very successful meeting with an enormous number participating in the International sessional meeting which shows that there is a great deal of support and interest in developing this area within the society. Over the past few years we have explored lots of ideas as to how SPNHC might become a more international society and in truth I think we have made some progress in this area; having annual meetings outside North America and signing Memorandums of Understanding with key societies and groups with similar interests.

In the past year I worked to set up a group of emerging professionals from SPNHC, NatSCA and GCG. Their objective was to meet and discuss the different groups and then come up with three ideas as to how the three groups could and should work together. The first draft of their report is attached.

Moving forward I would like this year to start to realise some of the suggestions that have been made in the last few years. In the next year I would like to move forward in three key areas:

- 1) Continue to work with the emerging professionals in the three UK groups and try to identify similar groups in other countries.
- 2) Work with the membership secretary to explore the possibility of producing a map that details individual members and their expertise. More specifically, the concept comprises a world map with member locations highlighted with a dot acting as a hyperlink to details of their expertise.
- 3) Make some initial enquiries towards creating the first international node by exploring the possibilities through contacts already in place, holding an annual meeting in either South Africa or South America. I believe we can build on relations as a result of this.

First meeting of 'emerging professionals' group jointly between GCG, NatSCA and SPNHC, to progress the MoU of Summer 2014

4th December 2014

Many general points were discussed, and these are itemised under the broad headings below.

Internally

Firstly, we thought that we should all get to know how each society operates, and circulate a simple document about each society's structure and general operating pattern (e.g. dates of AGM's, committee meetings, regular seminars or workshops). This could even extend to a meet-up socially, although this may be difficult to organise! We would each then be able to identify our 'opposite numbers' on the respective committees and be able to work together more effectively.

A joint calendar (Google?) could be developed as a going concern, so that all are aware of the dates of upcoming meetings, events and workshops.

In order to avoid duplicating effort and make the best use of resources already produced (e.g. from courses and conferences), a list should be drawn up of all the resources currently in existence within each society (preferably digital resources). This can be used to populate new and improved web areas, and identify areas needing updating as well as those thus far uncovered. This will also assist in a more streamlined front end, whereby web visitors can be directed to the information they need more efficiently.

Public/member facing Resources

It is clear that an improved, streamlined web presence is needed, as this will be the first port of call for people seeking information. Possible ways to do this include:

- A central portal for the three societies' websites, avoiding cluttering the search results by directing traffic to one place.
- Creation of 'members' areas' on the GCG and NatSCA websites (SPNHC already have this) to add value to membership fees, and weed out those who have not paid. Behind this login wall would be a range of resources:
 - A collection of the aforementioned resources from previous courses and conferences.

- Case studies and 'how-to's', and a series of 'collections for the non-specialist' articles. Curatorial
 posts are increasingly merged, leading to people looking after collections with which they are not
 familiar.
- A high-end skills-sharing network, possibly with links to LinkedIn profiles for members wishing to be a part of it. This could link to a map in order for users to identify help close to them.
- A list of people willing to be mentors/host placements for early career curators (SPNHC already hosts such a scheme/has a committee for this).
- A list of curatorial suppliers (GCG already has this, although it needs updating).
- A list of funders, and tips on writing good bids. People could offer to help with/read over funding proposals as part of the skills sharing network.
- Advice on legislation/licences.
- Advice on conservation (GCG may be taking on the SPPC website, which could host palaeontological conservation articles).
- A list of links to other groups to go to for further information (e.g. the MA, Collections Trust, the Geological Society for GCG, and other groups identified via the survey).

A physical toolkit cold also be created, with equipment that smaller museums may not have access to – e.g. microscopes (SPNHC already do this), training equipment. The Rapid Response Network in the North of England host emergency/salvage equipment at 'Hub' locations – could we learn from them?

Outreach

We need an outreach 'kit' which could potentially be used by all three groups. Handling specimens would be good, although it was thought best to purchase/commission these specially, to avoid undue museum paperwork. We also need to think about new audiences to raise profile and support, for example university students. Careers days could be visited (e.g. Geol Soc at BGS), both to explain museum careers and to showcase collections and their uses, which could help to win new advocates.

Profile and lobbying

It was felt that the profiles of all three societies could be raised by jointly undersigning documents and campaigns. More needs to be done to engage with the MA, ACE and other national museum bodies, and a clear and coherent voice will help with this. Perhaps an article could be written to highlight the new MoU and any upcoming activity (e.g. the Geodiversity Forum), as well as give clear mission statements and contact details.

Collections/Collections at Risk Officers could have the role slightly tweaked to be something like 'Campaigns Officers'. This makes a more proactive role, and a potential point of contact for those needing advice and some advocacy. It also opens the way for coordinated campaigns in future, whatever they may be.

Campaigns Officers could also work closely with Press Officers – these may exist on committees already – or the role could be shared. The ability to produce press releases quickly in response to news stories or to highlight otherwise unknown issues would be very valuable.

A joint membership arrangement/rate was discussed, and although it would be very difficult to administrate, it would streamline users' options, and potentially spread membership income more evenly across the societies. Joint introductions/statements of purpose by each chairperson could be written in each of the three respective journals, perhaps on a regular basis.

Medals could be awarded to recognise professional achievement in curatorship (GCG already award the Brighton Medal every three years). One could be for a curator in the first five years of their career, another for a more experienced curator – a potential name for this medal could be the Sloane Medal (after Sir Hans Sloane). These would add a badge of honour to natural science curation, and hopefully raise the status of the profession. GCG is affiliated with the Geological Society of London, and this could perhaps be exploited more, and other affiliations explored.

Competitions/awards and bursaries should be explored in a more coordinated way. NatSCA currently offer bursaries, and GCG is working with Rockwatch to offer a children's competition.

The patrons of NatSCA could perhaps be used more effectively and jointly, for campaigns and lobbying, or to promote specific events.

US Federal Collections

SPNHC represents a broad community of people who have responsibility for the management of publicly owned collections in the U.S.A., including both employees of Federal agencies and collections care staff from non-Federal repositories. The Federal Collections Sessional Committee is charged with exploring the challenges this

community faces in improving standards of collection care, documentation, accountability, and usage. Having done so, it will make recommendations to the Society's Council on ways in which SPNHC can facilitate improved communication and collaboration between Federal and non-Federal entities in the management of collections. The Committee has worked with the Local Committee of the 2015 SPNHC meeting to organize a half-day session at Gainesville exploring some of the most commonly encountered issues affecting the management of Federal collections, including permits, repository agreements, collection inventories, intellectual property rights, and the development of best practices. The sessional committee chair also provided input to the Society's response to the Proposed New Information Collection (OMB Control Number 1084- XXXX) by the Department of the Interior, entitled "Documenting, Managing and Preserving Department of the Interior Museum Collections Housed in Non-Federal Repositories"

Representative Reports

Alliance of Natural History Museums of Canada (ANHMC)

No report to SPNHC this year

American Alliance of Museums (AAM)

The position of SPNHC representative to any Committee of the AAM is currently vacant.

American Institute for Conservation of Historic and Artistic Works (AIC)

No report to SPNHC this year

American Society of Ichthyologists and Herpetologists (ASIH)

The 2014 meeting of the ASIH was held in Chattanooga, TN 30 July-3 August 2014. At this conference, ASIH met jointly with the Society for the Study of Amphibians and Reptiles (SSAR), Herpetologists' League (HL) and the American Elasmobranch Society (AES). Officially, 972 herpetologists and ichthyologists (461 of whom were students) from 22 different countries attended the meetings. The ASIH Collections Committee meeting was attended by 22 people, representing 20 different collections. The Collections Committee discussed Best Practices, and funding sources and the possibility of an ASIH Award for Collection Stewardship to be awarded annually. The details of the award are to be explored in subcommittee and presented at the 2015 annual meeting in Reno, NV.

American Society of Mammalogists (ASM)

Since 1972, the American Society of Mammalogists (ASM) has had a standing committee called the Systematic Collections Committee as an outgrowth of an *ad hoc* committee formed at the request of the National Science Foundation. Committee responsibilities include: (1) Advising curators worldwide in matters relating to collection administration, curation, and accreditation; (2) maintaining a directory of mammal collections and conducting a survey of existing collections approximately once each decade; and (3) maintaining a list of curatorial standards for mammal collections and managing a collection-accreditation program under the auspices of the Society.

On-site evaluations are conducted by committee members at institutions seeking ASM accreditation. The prospective collection also completed a detailed questionnaire that helps guide the on-site visit. Once this process has been completed, the Committee forwards its recommendations to the ASM President for review. The President then notifies the collection's administration of the Committee's decision. If accreditation is to be conferred, the President sends a letter to that effect as well as an Accreditation Certificate and a copy of the Final Report. Final Reports generally contain both positive observations and recommendations for improvement. The latter rarely comes as a surprise to collection staff. Rather, the Committee works with the staff to articulate areas for which they need greater administrative support. It is hoped that our recommendations will highlight the importance of the collection to the mammal research community and help to leverage greater institutional support for the collection.

This year, the Committee led by Dr. Robert Dowler, Curator of Mammals, Angelo State Natural History Collections, engaged in the following activities:

- At the 2014 annual meeting in Oklahoma City, a subset of the committee conducted a site visit in the
 Collection of Mammals of the University of Central Oklahoma, Collection of Vertebrates (UCOCV). A report
 was prepared based on materials provided by the staff and the on-site visit. The curators were officially
 notified that the UCOCV had received accreditation from the American Society of Mammalogists effective
 22 December 2014.
- Personnel at three collections, Oklahoma State University, the University of Iowa, and Colección Boliviana de Fauna (CBF) in La Paz, contacted us with questions about ASM accreditation or reaccreditation.
 Information was provided and the curators were encouraged to move forward with the process.
- The Committee began a survey of mammal collections to update our information on mammal collections of the Western Hemisphere. Beginning in May 2014 committee members began contacting collection

- curators. Although much progress has been made, there are many curators who have not responded yet. This will be discussed at the annual meeting in June, but still hope to complete the survey during 2015.
- A paper published this past year by Bradley, Bradley, Garner, and Baker, "Assessing the value of natural history collections and addressing issues regarding long-term growth and care" in Bioscience will be posted on the Systematic Collections Committee website.

International Society for Biological and Environmental Repositories (ISBER)

No report to SPNHC this year

Natural Sciences Collections Association (NatSCA)

It was another busy year for NatSCA, as Natural Science collections continue to face a variety of threats in the UK. The biggest problems facing collections continue to be posed by reductions in funding. The financial support for museums of all sizes has been decreasing every year, with jobs being lost and stored collections often bearing the brunt of cuts. NatSCA has been to trying to keep track of threats to collections and offer our support in an effort to make the vital role of collections, and the people with the skills to care for them, more clearly recognised by management.

As the funding situation continues to tighten its grip on many museums and their staff, NatSCA continued to work to highlight the value of Natural Sciences collections and the specialist staff who care for and maintain those collections

In our role as the UK Subject Specialist Network (SSN) for natural science collections we have met with representatives of ACE and the UK Natural Science Consortium to discuss the future of natural science collections at a strategic level, with a view to understanding and combating the threats to collections. The UK Collection Consortium comprises 22 major Museums, Galleries and Archives. Many NatSCA committee members have been involved, taking on specific roles to support and provide input on various working groups for this consortium.

In the interest of reaching wider audiences NatSCA welcomed evolutionary biologist and BBC presenter Ben Garrod as new patron. Ben joins Professor Alice Roberts and Professor Iain Stewart who in their role as patrons have helped to raise the profile of natural science collections whilst showing tremendous support for the Association and its work. http://www.natsca.org/patrons

NatSCA has also created another avenue to publish and discuss natural science collections issues. NatSCA Notes & Comments are electronic-only publications that are not peer-reviewed and do not necessarily represent the views of NatSCA. These papers provide an opportunity for sharing opinions and information that may be of relevance to the society's membership, natural historians and the wider museums sector.

The <u>first issue of our new online publication NatSCA Notes & Comments</u> provides a case study of decline from the Midlands, written by Geoffrey Hall. Although the picture painted is bleak, there have been some small wins, as <u>Ludlow</u> has since acknowledged the importance of maintaining a geologist to manage their globally important geology collection.

For peer-reviewed articlesNatSCA continues to publish the <u>Journal of Natural Science Collections</u> and for short articles the <u>NatSCA blog</u>.

As in previous years we ran several very successful and well attended workshops and training events. The topics covered range from Hazards in Museum Geological Collections, Identification of Osseous and Keratinous Material, Caring for Botanical Collections, Understanding Museum Taxidermy: Construction, Care and Commissioning

among others. We will continue to run more over the course of the year, so for updates on the events programme consult the relevant section in the NatSCA website. http://www.natsca.org/events-and-workshops

As in previous years, we have kept supporting our membership through bursaries for workshops and conferences. In the ever constantly changing legal world, it is sometimes difficult to keep abreast of all new legal requirements, but it is possibly now more important than ever for institutions to ensure compliance and transparency. NatSCA has strived to provide advice to our membership on this arena and when necessary raised issues on behalf of the museum sector and engage in discussion with the appropriate governmental offices.

NatSCA corresponded with the Department of Environment and Rural Affairs (DEFRA) on the issue of the possession of egg collections and the legal requirements. As a consequence DEFRA has acknowledged that changes to the law were not fully consulted on and are now seeking to rectify this by holding a public consultation. This new consultation should hopefully take into consideration museum collections and their idiosyncrasies. NatSCA has also been working on resolving the problem of museum drugs licensing for a couple of years now. We are currently working with the National Museum Directors Council and the Home Office on reducing the costs of the current drugs licence for museums. It is proposed that accredited museums will qualify for a licence that would span 5 years and cost less than the annual renewal and twice yearly spot checks of the current provision. Museums currently without licences would still have to pay for the initial expense of setting up the licence. NatSCA is also working on producing guidelines for museums who cannot afford a licence.

The SPNHC, GCG, and NatSCA emerging professionals group had their first meeting at the Natural History Museum and have produced a document that outlines some ideas and projects for the societies to work together on.

UK oganisations like NatSCA, that have an interest in maintaining natural science collections in Britain and Ireland, also have need for a database of collections to facilitate advocacy work. In order to address this need NatSCA and various partners (including the <u>Linnean Society</u> and the <u>NHM</u>) are undertaking a sector-wide project to develop an information system for natural science collections in the UK and Ireland, under the working title <u>#NatureData</u>. Over the past year we've been involved in development of a resource to collect and share collections level data for the natural sciences in the UK and Ireland.

On addition, NatSCA has also met with the <u>National Forum for Biological Recoding</u> and discussed societies overlapping interests.

Graham Walley from NFBR presented a summary of their remit which covers everything to do with Biological Recording in the UK.

Their main current objective is to identify how the future needs of all sectors of the biological recording community, the various users of biodiversity information and the support infrastructures on which they depend may best be addressed.

Therefore NFBR is also interested in what is happening on our field.

This was the last year of the Heritage Lottery Fund (HLF) funded "Skills for the Future" programme. This programme has provided paid training for up-and-coming natural science curators, and has been very successful and useful for both the trainees and the institutions that hosted them.

NatSCA's public profile continues to grow and the society got a mention in Nature in an important feature article on the decline of natural science collections.

NatSCA has also been developing a strategy document which will serve as a guide to the society's activities and projects, providing greater transparency to members on the committee's decision making process. Through the combined efforts of the committee and members, we keep active on all fronts and look forward to developing our partnerships and working more closely with both the Society for the Preservation of Natural History Collections (SPNHC) and Geological Curators' Group (GCG) over the next year.

Natural Science Collections Alliance (NSC Alliance)

The NSC Alliance has been working to develop a new organizational strategic plan. The Board of Directors will be meeting during the SPNHC meeting to further consider the plan and other organizational initiatives. Among ongoing NSC Alliance efforts are participation in the NIBA Research Coordination Network.

A core focus of the NSC Alliance remains national policy advocacy. In recent months, the NSC Alliance has alerted the community to the opportunity to inform policy developments at the Department of the Interior, has commented on Interior proposals, has provided congressional testimony in support of increased funding for collection-related research at the National Science Foundation and the US Geological Survey, and has participated in coalition efforts to encourage federal policy changes that would enable federal scientists to travel to scientific conferences.

In the coming months, NSC Alliance will cosponsor the 2015 Biological Sciences Congressional District Visits event in August. It will also cosponsor an upcoming Communications Workshop in conjunction with the research coordination network.

Scientific Collections International (SciColl)

SciColl is affiliated with the Consortium for the Barcode of Life (CBOL), which is the same group that manages the GRBio website. GRBio applied for funding from NSF last year to finish the programming for the site, in particular to make a dedicated connection to *Index Herbariorum* so that new information would be reflected in both systems. This work was not funded, but GRBio did receive an RCN grant to hold two workshops to explore the functionality of GRBio with the natural history collections community, and a second one for the same topic, but with other collection types represented in SciColl.

The first workshop was held 27-29 April 2015 in Washington, DC. The workshop was devoted to gathering community input on the design of a new version of the Global Registry of Biodiversity Repositories (GRBio). CBOL and SciColl envision several roles for GRBio. The original motivation was to create a central, authoritative source of information on natural history collections. The rapid digitization of collections (accelerated by national initiatives such as NSF's ADBC Program) and the growth of data aggregators (e.g., GBIF, VertNet) have made it even more important to have a source of information about collections. After 18 months of operation, CBOL and SciColl are beginning to plan for a new version of GRBio. Its design will reflect the community's vision for its long-term role.

There were about 25 participants at the workshop They included a mixture of people, including representatives of collections, databases of various kinds, and leaders in the broader field of biodiversity informatics. Two SPNHC council members were in attendance: B. Thiers and Andy Bentley. The diversity of viewpoints at the workshop challenged GRBio to think hard about clarifying GRBio's mission and goals going forward. A report on the workshop is pending. The second workshop is scheduled for the fall of 2015.

There are other recent, unrelated developments in the attempt to document collections and their holdings. IDigBio has recently published a list of natural history collections in the U.S. (https://www.idigbio.org/portal/collections) and GBIF has convened a task force called "Accelerating the discovery of bio-collections data" whose charge is "to prepare a white paper on how to reach more collections worldwide in order to catalyze the publication of as many as 1-2 billion specimen records important for the sustainability of our planet."

Small Collections Network (SCNet)

SCNet has been active in recruiting, retaining and supporting small collections in the last year. As a follow up to the

SPNHC 2014 Small Collections Symposium, SCNet was introduced and ongoing activities were highlighted in the SPNHC sponsored Collections Forum. The SCNet webinars (co-sponsored by iDigBio) continue to garner interest, with topics centered on supporting small collections and establishing SCNet as a collaborative resource for small collections and the professionals who manage them (recorded webinars can be found on the SCNet webpage: http://scnet.acis.ufl.edu). SCNet was pleased to be represented at the 2014 annual meeting of the Entomological Collections Network (ECN), Gil Nelson (iDigBio) and Christy Bills (University of Utah and ECN) presented a session entitled Mobilizing Dark Data: Raising the Profiles of Small Natural History Collectionshttp://www.idigbio.org/sites/default/files/working-groups/SCNet/Nelson ECN 2014.pdf>. This presentation generated interest on several levels and was followed up by a roundtable discussion that focused on issues of "dark data" and how to define "small" across collection types. SCNet was represented at Botany 2014 where the North American Network of Small Herbaria and iDigBiohttp://idigbio.org/ co-sponsored a small herbarium digitization workshop. In early 2015, SCNet and iDigBio sponsored a session at the annual Small Museum Association Conference, where representatives did a brief presentation followed by a roundtable discussion highlighting current SCNet initiatives, opportunities for collaboration, and strategies for promoting and enhancing small museums and collections. iDigBiohttps://www.idigbio.org/, SCNet, and the Natural Science Collections Alliancehttp://www.nscalliance.org/ are pleased to sponsor a second small collections symposium at the upcoming SPNHC 2015 conferencehttp://www.flmnh.ufl.edu/spnhc2015/home/, with 22 invited talks on the

challenges in small collections and museums, and Reaching out to small collections.

The Society focuses on promoting the importance of herbaria in teaching, research, and service to the community at large. Members are active in the continued development of regional and/or state-level consortia and are participating in both regional efforts and the US Virtual Herbarium project.

Society of Vertebrate Paleontology (SVP)

The 74th Annual meeting of the Society of Vertebrate Paleontology was hosted 5-8 November in Berlin, Germany, and was attended by numerous SPNHC members. This year's meeting is planned for 2015 in Dallas, then 2016 in Salt Lake City, and 2017 in Calgary.

The SVP wishes to remind SPNHC members that it offers several awards and grants that might have relevance to those interested in vertebrate paleontology. These include grants [http://vertpaleo.org/Awards.aspx] to promote student research and fieldwork, like the Estes, Patterson, and Wood awards. The Jackson Student Travel Grant and Scientists from Economically Developing Nations grant both help support travel to the SVP annual meeting. The Hix Preparators Grant is awarded to advance fossil research, standards, and training in preparation and collections disciplines. Not all of these awards limit eligibility to current members of SVP, check the requirements carefully.

Of note to those working with paleontological collections, the United States Forest Service published new regulations governing paleontological resources preservation in the Federal Register on 17 April, 2015. These regulations apply to both permitted researchers and non-Federal repositories who hold USFS resources in public trust.

Taxonomic Databases Working Group (TDWG)

The 2014 annual meeting of the Biodiversity Information Standards (TDWG) was held in Jönköping, Sweden in October. The theme of the meeting was "Applications and Data Standards for Sustaining Biodiversity" and an archive of the meeting website, which includes the program and links to the abstracts can be found at: http://www.tdwg.org/conference2014/ Highlights included a pre-meeting workshop on Globally Unique Identifiers (GUIDs), a symposium and workshop on citizen science, and a tutorial and workshop on the Darwin Core.

Of note this past year has been action to revise/update the Darwin Core standard to address a broader variety of organism-based relationships, the samples made of these, and a richer ability to connect/extend to genomic data and emerging standards. At the same time, we are attempting to better document the standard terms with more detailed definitions and examples to aid users in implementing the standard. If you are interested in this process, I would urge you to sign up for the TDWG-content mailing list as this is where the core discussion on this and other standards takes place.

As I continue to stress: "the standards being evaluated by TDWG, and the applications that implement them, have a direct impact on many SPNHC members involved with specimen data capture and curation." Thus, I would suggest participating in the many topical Interest and Task Groups found on the TDWG wiki. Finally, TDWG is making a strong effort to expand its base membership and I would encourage anyone who has interest in standards and informatics tools to join.

The 2015 meeting will be held in Nairobi, Kenya from September 28th to October 3rd. Our first meeting in Africa

NOTE 1 - Summary of Significant Accounting Policies

The Society for the Preservation of Natural History Collections (the Society) was formed in 1985, and then incorporated in 1988 under the laws of the state of Pennsylvania. The Society seeks to improve the preservation, conservation and management of natural history collections to ensure their continuing value to the society. Substantial support is received from approximately 600 members, representing 21 countries, who are interested in the development and preservation of natural history collections.

Support and Expenses

Contributions are recognized when the donor makes a promise to give to the Society that is, in substance, unconditional. Contributions that are restricted by the donor are reported as increases in unrestricted net assets if the restrictions expire in the fiscal year in which the contributions are recognized. All other donor-restricted contributions are reported as increases in temporarily or permanently restricted net assets depending on the nature of the restrictions. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets.

Member support received in advance of the membership period is recorded as deferred in the accompanying statements of financial position.

Expenses are recorded when incurred in accordance with the accrual basis of accounting.

Fair Value Measurements

Accounting principles generally accepted in the United States established a framework for measuring fair value, clarifying the definition of fair value within that framework and expanding disclosure about fair value measurements. U.S. GAAP established a three-tiered fair value hierarchy with Level 1 representing quoted prices for identical assets or liabilities in an active market, Level 2 representing quoted prices for identical assets or liabilities in an active market that is non-active or with other than directly or indirectly observable inputs, and Level 3 representing estimate values based on unobservable inputs. Related disclosures are segregated for assets and liabilities measured at fair value based on the level used within the hierarchy to determine their fair values.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Cash Equivalents

For purposes of the statement of cash flows, the Society considers all short-term non-restricted investments to be cash equivalents.

Inventory

The Society maintains an inventory of professional books for sale to members and to the public. Inventory is recorded at lower of cost or market.

Investments

Investments are reported at market value using level 1 methodology. Contributions of marketable securities are recorded at their fair market value at the date of donation.

Intangible Asset

The Society capitalized expenditures related to long-term functional website building and design fees. Expenditures for ordinary maintenance and updates are charged to operations as incurred. When management deems the property to be impaired beyond further use, the remaining unamortized balance is expensed in the current year. The cost and related accumulated amortization are then eliminated from the accounts. Amortization is provided for under the straight-line method over a period of three years.

Classes of Assets

To ensure the observance of limitations and restrictions placed on the use of resources available to the Society, resources for various purposes are classified for accounting purposes into the following classes established according to their nature and purpose.

<u>Unrestricted net assets</u> are the net assets that are neither permanently restricted nor temporarily restricted by donor-imposed stipulations and includes Board designated funds, i.e.: funds that have been segregated by the Board to be spent only on specified purposes.

<u>Temporarily restricted net assets</u> result from contributions whose use is limited by donor-imposed stipulations that either expire by passage of time or can be fulfilled and removed by actions of the Society pursuant to these stipulations. Net assets may be temporarily restricted for various purposes, such as use in future periods or use for specified purposes. The Society has no permanently restricted net assets.

Tax Exempt Status

The Society has been granted exemption from income taxes under Section 501(c)(3) of the Internal Revenue Code, as amended and is classified as other than a private foundation. Therefore, no provision for income taxes has been made.

Management evaluated the Society's tax positions and concluded that the Society had taken no uncertain tax positions that require adjustment to or disclosure in the financial statements. With few exceptions, federal and state information returns for the years prior to 2011 are no longer subject to examination by tax authorities.

Subsequent Events

The Society evaluated its December 31, 2014 financial statements for subsequent events through February 10, 2015, the date the financial statements were available to be issued.
