- <u>The Vendor Recognition Award</u> recognizes longtime, repeated, and substantial acts of support of the Society and the Society's annual meetings by a commercial organization; this year the Vendor Recognition Award goes to University Products, for their longtime support of the museum community, the Society, and the SPNHC annual meeting. PM noted they did not have a physical presence in Scotland, so he will make sure the award is mailed to them.
- 2. <u>The Early Career Award</u> is presented to a member at an early stage in their career or at an early stage in their involvement with SPNHC and who has demonstrated great potential for leadership through innovative and energetic services that strengthen and broaden the impact of SPNHC. The inaugural award was given to Elizabeth "Libby" Elwood, who has demonstrated great initiative and energy in her leadership of the Biodiversity Crisis Committee. PM noted that he can't think of anyone better to receive that. Under Libby's leadership, the SPNHC Biodiversity Crisis Committee has done an amazing amount of work in a very short time, building momentum in several important areas. Some of these activities include the community survey and actions to the Conserve Biodiversity panel discussions, have engaged the collections community in reflections on its role in countering the biodiversity crisis, and others—

for example, as SPNHC representative to the Convention on Biological Diversity and the roundtable discussion at the national Nature Serve conference, which have elevated our organization's presence in the conservation community. The panel discussion alone drew over 250 participants from around the world. The response to the Biodiversity Crisis Committee's work is due, of course, to the importance of the topic but also very much to Libby's sophisticated, inclusive, and generous approach to supporting groups with a common objective.

The SPNHC Special Award recognizes individuals and sister organizations for any 3. noteworthy effort leading to the success of an important event or activity or objective of the Society. This year BT was delighted to present the award to Local Organizers of this year's conference: The National Museums of Scotland and the Royal Botanical Garden Edinburgh. Organizing a SPNHC conference is always a challenge, but this conference, with its long delay from its original date in 2020, and organizing during the time of COVID, brought all kinds of special challenges, PM expressed that he could not imagine postponing the meeting after all that work was done for 2020, and that everyone he's talked to has raved about the field trips, and he's seen many images of the fossil lungfish embedded in the museum walls posted on Facebook, the cruise was excellent, the presentations and lectures went seamlessly, the social activities have provided a lot of entertainment and fun, and the organizers have done a wonderful job, and everyone has fallen in love with Edinburgh, the NMS, and the RBGE, which have been great venues, so thank you very much. Sankurie Pye, representing the Local Organizing Committee, thanked everyone and said the LOC was greatly honored and had a great time too.

b. Upcoming Meetings: Julian Carter

- 2023 Cal Academy, San Francisco: Moe Flannery, a co-chair from the 2023 meeting LOC, expressed that they hope everyone will join them in San Francisco CA, May 28 through June 2, 2023, that it has been really great to be here in person this year and talk with everyone and share this space in Edinburgh, and she hopes they'll bring together lots of people from around the world again next year. MF introduced co-chair Laura Eckland, who was also on the call, and summarized their plans: hybrid meeting to the best extent possible; the venue will be the San Francisco Hilton Union Square, where they've reserved a block of rooms; MF encouraged people to stay there, as it will support the cost of the meeting, is easily accessible to the rest of downtown San Francisco, and it will be convenient to simply go downstairs from the hotel rooms to the conference halls and visit the rooftop bar with a swimming pool; most of the conference will happen at the Union Square Hilton, and the ice breaker and collection tours will be at the Cal Academy of Sciences in Golden Gate Park; they are having conversations about collection tours at the Museum of Vertebrate Zoology at Berkeley; there will be field trips to places like wine country, the Monterey Bay Aquarium, Muir Woods National Monument, and let them know of other places you'd like to go; there will be lots of workshops and amazing talks, a banquet, trivia nighteverything you'd expect from SPNHC, plus San Francisco as well. MF presented a video and made comments about what San Francisco has to offer: baseball stadium Pier 39; sealions; sail on the bay; Alcatraz; might be foggy, so bring warm clothes, like Edinburgh; culinary delights; Golden Gate Bridge; different cultural areas; other museums, such as the Asian Art Museum; trolley and cable cars; shopping; travel in the countryside, with Muir Woods just 1 hour north of the city; wine country; Monterey Bay Aquarium; sea otters; Hilton, with its rooftop view-the highest sky bar in San Francisco and heated pool—and great views from the rooms as well; Golden Gate Park with the Cal Academy and its living roof; the icebreaker will be at museum on first evening, where you can visit Claude, the alligator with albinism and 40,000 other live animals, including our favorite penguins. MF thanked the Edinburgh LOC for all they did and invited everyone to view the San Francisco website that just went live: calacademy.org/spnhc-2023. MF invited suggestions for symposia or additional emerging professional activities, which can be sent to

spnhc2023questions@calacademy.org; the call for symposia and workshop ideas will

be sometime in the next few months, and registration will begin in early January, with abstracts due around then as well. MF encouraged people to book their hotel rooms soon and will circulate the block code to membership. MF and LE look forward to welcoming everyone in San Francisco next year.

- 2024—possibly Okinawa, Japan: JC noted that SPNHC is working with TDWG to organize a meeting in Okinawa, Japan, and that the committee is still exploring whether it will be possible without a host LOC on the ground there. Normally we would have a letter of invitation now for approval at the ABM, but we don't have that yet, as we are still looking into costs and will decide within the next few months. Without a host LOC, SPNH will have to put money up front to support the conference, which includes risks. The conference might be expensive for some participants, but it will enable connection with Asian and Australian areas as well. JC noted that SPNHC worked well with TDWG in Dunedin for the 2018 meeting. Deb Paul noted that SPNHC would be cost sharing with TDWG, so not assuming all the risk. JC noted that SPNHC will have to take on more responsibility for organizing our annual conferences in future, due to the increasing burden on LOCs, and that the Conference Committee will make a decision on whether Okinawa 2024 is feasible, followed by an online vote of membership. JC reported that Mariko Kageyama has been making and coordinating contacts in Japan, and that Daisuke Sakama is willing to serve as co-chair, along with a TDWG rep. The exploratory committee is also in talks with a local conference-organizing vendor who would provide logistical support and liaise with hotel(s). MK expressed thanks for serious consideration of holding a conference in Asia, which would be the first and a huge opportunity to engage with Asia. JC noted that it definitely would be in line with SPNHC goals to expand its international reach, as well as a great opportunity for collaboration.
- <u>2025 Yale University, New Haven, Connecticut</u>. JC noted that SPNHC is returning to Yale to celebrate SPNHC's 40th anniversary and the Yale Peabody Museum's new building.
- Beyond that, JC noted that the committee is exploring further options, potentially with a consortium in South Africa, and possibly returning to London in 2027 or 2028. PM expressed that things are changing and that conferences cost 100s of thousands of dollars up front and rely on registrations and vendor support to break even; SPNHC will have to reconsider how we hold and fund our meetings.
- **Treasurer situation?** PM stated that another area in which we need to look at changing C the way SPNHC operates is in its financial administration. Everyone involved with treasury, membership, and publications agrees that we need to hire someone to take on some of these duties. The Society is getting too big as an organization, making a lot of work for a handful of people to handle, and it would be in the best interest of SPNHC to hire a professional to take on the financial aspects of our finances, publications, and membership, to free up those committees to do other committee work, instead of the daily transactions. It's a tremendous amount of work done by 2 or 3 people, and we've been lucky to have people to do that work for a long time, but it's getting to the point now where something's going to give; we've looked at a few people and have some rough ideas of cost: it might eventually lead to an increase in dues, but we'll be looking at ways to increase benefits to members. CO noted that a Finance Committee has formed to look at options to present to membership. PM alerted membership to two big changes in the way SPNHC conducts business in the near future, so watch for news-on funding the Japanese meeting (Okinawa 2024) and hiring a professional to do the accounting work for SPNHC. DP cited a question in the chat about whether meetings will be hybrid and live in future, and answered, "Yes," noting that it gives us the opportunity to increase the Society's diversity as we aspire to do.

PM thanked outgoing past-president Barbara Thiers, who was a constant source of information for PM and helped him in all kinds of ways. PM also offered a very big thank you to Secretary Cindy Opitz, who is stepping down after six years in the role and has been absolutely wonderful to work with—he couldn't have done his job without her. CO confirmed that she is now co-chair of the Conference Committee and continue attending Council meetings.
- PM welcomed our two new Members-at-Large—Irene Finkelde and Jennifer Trimble (2022–2025), whose 3-year terms are now beginning—and welcomed incoming President Julian Carter, President-elect Greg Watkins-Colwell, and Secretary Tiffany Adrain, whose two-year terms begins at the end of this meeting and who he thanked for her long-time work chairing the Membership Committee.
- CO announced that Andy Haycock is the new Geological Curators Group representative. PM thanked AH and noted that we've been trying to fill that position for a long time.
- Thanks, serving as president has been true honor, lot of change and challenges coming; we're in good hands with JC, GWC, TA; need more input from membership, more diversity, consider joining committees and making your voices heard.
- PM thanked everyone for the opportunity to serve as the president, which was a true honor he really enjoyed. He expressed confidence that Julian Carter, Greg Watkins-Colwell, Tiffany Adrain and the entire SPNHC Council will do a great job handling the challenges and changes to come in the next couple of years. PM noted that they'll need help and encouraged everyone to volunteer to work on committees, as we'll need more hands, more input, and more diversity.
- Andy Bentley thanked everyone involved with providing the online portion of the Edinburgh conference, for those who couldn't attend in person, and hoped that there will be opportunities to attend committee meetings and the banquet and other social events online in some form in the future. AB wished safe travels to all returning to their native lands from Edinburgh.

Report of the President

At the 2022 meet in Edinburgh it was an honour to officially take over the role of the SPNHC President from Paul Mayer, and on behalf of the Society thank Paul for his hard work and dedication as President, and particularly in guiding the society through the challenges of the Covid pandemic during his tenure. This year sees the ABM return to North America hosted by the wonderful California Academy of Sciences. The Local Organizing Committee (LOC) has been working exceptionally hard to bring this meeting together, which will once again be a hybrid conference with virtual options to attend. On behalf of the Society, I would like to thank the whole team, who under the leadership Laura Eklund and Moe Flannery, have undertaken the major task to bring this superb conference and our community together to share knowledge, skills, and experiences.

Council Changes

For this coming year we have some changes on the Council as two of our members at large finish

their terms, and we extend our sincere thanks to Shelley James and Randy Singer for their valuable support for the work of the Society and the Council. In return we extend a warm welcome to the Council for our two new incoming MaLs Dirk Neumann and Stéphanie Tessier. We have also enacted on the proposal at the 2022 ABM to employ additional support for the membership and business administration of the Society to improve the efficiency of how the Society operates. This has resulted in the hiring of Christy Classi and her team to manage the SPNHC memberships and business office website. The appointment is already proving a positive move and showing benefits in the administration of the Society and its work. As a result, we are now proposing to bring the role of the Membership Committee chair formerly onto the Council to further facilitate and improve communication and management of the governance of SPNHC as this role interlinks strongly with other key roles such as the Treasurer and Secretary.

Future Planning

Prior to the Covid pandemic the Society, via the Long-Range Planning Committee, had begun the process to review the strategy and aims of the organization and the previous 10 year plan which had come to an end. Unfortunately, the ongoing challenges of this period had understandably caused this project to stall. This has now been picked up again by the LRP with the initiation of a membership survey, the initial results of which should be with us for the 2023 ABM. The feedback from the survey will then form the basis to review and develop a new 10-year strategy for the Society over the coming year. This work will also be linking to the need to review the financial security of SPNHC in response to both the increased costs we are now incurring, and to better support the membership and work of the Society in the future. As a result, we have now also reinitiated the Finance Committee to lead on a financial review for SPNHC.

Standing Committees

The backbone to the Society is very much in the work and outputs of the various Committees and liaison groups, and a big thank you goes to all the chairs and members of all the various committees and groups, both past and present. At the time of writing, it is not possible to list all the changes but a special mention goes to Mariel Campbell who has had to step down from her role as Managing Editor of the Publications Committee and we very much thank Mariel for her work and commitment to this key role for the Society.

The work of our committees is more fully reported upon in the reports in this ABM package and represents a key part of the strength of the organization. The scope and diversity of these reports fully illustrate the wide range of activities that SPNHC members undertake supporting our collections and community, providing our membership a valuable voice across the sector. We thus actively encourage you to join in the work of these committees as they can be a great opportunity to meet new people, share expertise and skills, and make your voice heard.

The Council and associated Committees have also been aiming to meet quarterly via Zoom to help improve communications and support moving Society business forward throughout the year. In addition, the Society has upgraded its Slack account and many of the channels on that account are open to all members to join and use. SPNHC also has both the Zoom and You-tube channel accounts which are there to support the society and its membership, so please do get in contact if you would like to use these accounts to host a relevant meeting, event, or activity.

Future ABMs

Another area undergoing review is considering how we can better support the annual meeting. The challenges and expense of hosting this meeting have grown considerably over the years, more so following the Covid pandemic where factors such as offering a virtual attendance are now considered a required part of the conference. This brings additional organizational challenges and costs that now need to be factored into the meeting guidelines. The joint meeting currently being developed with TDWG in Okinawa for 2024 is an important example of the increased agility now required to deliver the annual meeting as it does not have a local hosting venue with an associated local organizing committee to rely on. It is hence being developed by a mixed committee being formed from the societies involved working with a conference organizer in

the region. The experiences from this, and our other recent annual meetings will all support how we support and guide future annual meetings.

Thankyou

The society is very much run by the community it is a part of, driven by an immense amount of enthusiasm and passion from its members, and it continues to support numerous initiatives both with our kindred societies and from the wider associated community. There are regular requests for support and collaboration such as letters of support for NSF and other grant proposals. Many of these requests are around improving and sharing access to the collections and their data, reflecting the ongoing drive in these areas in response to wider societal challenges. We are currently in a period of great change with the effects of climate change, along with the ongoing impacts of the current world situation, and the value of our work and collections to society has never been greater. Responding to this, SPNHC is looking to evolve and move forward, and we will endeavor to be involved in a positive way as fully as possible. So please do get involved in some way if you can via engaging with the activities of the committees and associated groups, sharing our work on social media, supporting our advertisers, or using the strength of the Society to develop new initiatives and activities. In the meantime, I look forward to hopefully seeing many of you in San Francisco in May at the annual meeting, and I thank all the whole team for their inspirational support and guidance over this past year to both me in the presidential role and to the Society.

Report of the Treasurer

In 2022, the Society's total net assets increased to \$492,663 from a total of \$486,496 the previous year. Liabilities and net assets for 2022 totaled \$477,877. Operating income was generated from three sources: membership dues, publication sales, and advertising in the Newsletter. A total of \$23,669 in membership dues was received.

Sales of our seven publications plus royalty payments brought in \$18,012. A total of \$1,209 in donations were received.

The first part of 2023 has seen steady income activity and by April 30, \$20,735 has been received from membership dues.

Of the 330 SPNHC members in 2022, 50 joined for the first time. Membership renewals included 38 students, 216 individuals, 21 library/subscriptions, 53 institutional, and 2 corporate memberships.

As of April 30, 103 new members have joined for 2023, of which 41 are student memberships, 12 are institutional, and the remainder are individuals.

By April 30th, 630 members had yet to renew for 2022. Renewals for this year were sent to current and former members from 2020 through 2022.

As a reminder, we ask that all members please pay your dues on time.

The Treasurer's Office incurred \$27,412 in expenses which included \$3,360 for insurance, \$2,604 for Zoom, \$6,000 for Tax Preparation Services and 2022 taxes, and \$588 for the annual fee for QuickBooks.

Long-term investment funds were consistent with the market; SPNHC investments saw a slight

market value loss of \$10, while the money market account earned \$12,883 in dividends and interest. The CD account earned \$20 in interest.

Major expenses for the Society in 2022 included \$3,500 for tax preparation expenses. Additional expenses included \$99 for the 2022 election, \$295 for annual fees to CrossRef/PILA, \$315 for Oxford Abstracts, \$600 for Vimeo, \$2,052 for Wild Apricot Memberships Services, and \$6,750 contract agreement with Christy Classi.

The Society anticipates expenses related to publications, insurance premiums, online elections, and AIBS membership and continued contract payments for 2023.

STANDING COMMITTEE REPORTS

ARCHIVES

The Smithsonian Institution Archives (SIA) houses the archives of the Society for the Preservation of Natural History Collections (SPNHC). SIA currently holds 16 deposits of SPNHC material totaling 23.5 cubic feet. Examples of this material include Collection Forum, SPNHC, newsletters, documentation of annual meetings, financial files, election ballots, member-at-large files, various committee files, videos, CDs, and photographs.

The members of the archive committee act as liaisons between SIA and SPNHC. In preparation for the transfer to SIA, the documentation and material related to the activity of the Society are organized in archival boxes and a "finding aid" typed for each box. The material is arranged in folders with year, type of documentation and a brief summary of the folder's content. When known, files received from individuals are noted. Although the Society has moved to electronic publications, these are printed and cataloged for deposit. The finding aid along with the boxes are transferred to SIA, where an accession number is assigned to the deposit and the finding aid uploaded to the SIA website.

Material, documentation, images, and publications continue to be collected by the Archive Committee. Where possible, any material sent to the participants such as the book of abstracts, committee reports, schedules, etc. were printed. Mariel Campbell and Cindy Ramotnik sent several boxes of historical material that have been processed and have been submitted to the SI Archives. We are now gathering material, emails, and other documents pertaining to the 2023

meeting that will be held in San Francisco, California this year. Cindy Ortiz stepped down as Secretary last year and turned over paper and electronic documents that she inherited from previous Secretaries and material she generated during her tenure. This will be added to the next submission to SI Archives in the future.

BEST PRACTICES

The Best Practices Committee has made progress on building SPNHC resources this year. In addition to quarterly check-in meetings, we hosted two half-day virtual wiki working sessions (November 2022 and April 2023), with great attendance from committee members. Developments were made on landing pages, overall site organization, new content and linked web resources, as well as nine authorized Storage-At-A-Glance sections were uploaded from the *Preventive Conservation: Collection Storage* book (Elkin and Norris eds., 2020). New or heavily updated wiki pages this year include: Amber Ethics and Guidelines, Botany Specimen Preparation, Digital Imaging, Digitization, Fluid Collection Imaging, Numbering Natural History Collections, Persistent Identifiers, Shipping Collections, Shipping Large Fossils, and Microtomography (microCT). Thank you to all of our contributors.

At this year's annual meeting in San Francisco, the Best Practices Committee will host the symposium, "Back to Basics: Museum Techniques Skillshare" for the second year in a row. In this best practices-themed session, we look forward to author's sharing their practical knowledge with our community. Symposium talks will be made available on the SPNHC wiki following the conference to serve as a lasting community resource. Last year's presentations are now available online and can be accessed <u>here</u>.

In collaboration with iDigBio, we will again co-host a workshop, "Capturing community expertise: A SPNHC wiki edit-a-thon" to expand wiki content on all themes, with special emphasis on digitization topics. We will provide a brief training on wiki editing, and invite any SPNHC attendee to join us to create content of their choosing or help us with specific pre-packaged tasks.

BIODIVERSITY CRISIS RESPONSE

Over the past year, since SPNHC's Annual Business Meeting in 2022 the Biodiversity Crisis Response Committee continued to meet regularly every month. Meetings are opportunities to exchange news about the diverse engagements and activities of members, and to discuss current developments within the intersection of natural science collections and biodiversity conservation.

An important joint activity of committee members last year was a presentation at Botany 2022 in Anchorage, Alaska in July 2022 titled "Finding common goals between conservation biology and

natural history collections". The submission was initiated by Dina Clark, its abstract submitted by Alina Freire-Fierro and the development of the presentation led by Austin Mast. Austin presented the talk at the special symposium "Biodiversity at the brink: leveraging herbaria for conservation!" of the Society for Herbarium Curators to a well attended session. Building on the outcomes of the committee's strategic planning workshop of early 2021, the talk reviewed where we stand now 1.5 years later, and provided reflections on collections' strengths, weaknesses, opportunities and threats for contributing to biodiversity conservation. It will be important to continue to keep these reflections in mind and to revisit them regularly to assess our work.

Since last fall, our work as a committee has focused on preparing a symposium and associated conversation café at SPNHC 2023 in San Francisco. Both events approach the intersection of collections and conservation from the perspective of connecting a network of networks. We have invited members of global, regional, and local professional societies from across the world to introduce us to the engagement of their organizations for biodiversity conservation and discuss how we might connect as networks and individuals, bring together our work and link up our efforts in response to the biodiversity crisis.

CONFERENCE

The Conference Committee is co-chaired by Cindy Opitz and Greg Watkins-Colwell. The additional members of the Conference Committee are: Paul Mayer (Sponsor Liaison, North America), Sankurie Pye (Edinburgh 2022), Laura Eklund and Moe Flannery (San Francisco 2023), Shelley James (TDWG/Okinawa 2024), Mariana DiGiacomo (New Haven 2025), Tiffany Adrain, Elise LeCompte, and Irene Finkelde.

The committee thanks the 2022 Local Organizing Committee in Edinburgh for all their hard work, which resulted in an amazing conference and experience.

The committee meets via Zoom regularly. Meetings with the 2023 LOC started as monthly meetings but moved to twice per month in March 2023. Instead of a \$5,000 loan to the LOC, SPNCH purchased the license for Oxford Abstracts, which significantly helped the San Francisco LOC with much of the management issues involved in hosting a conference. The Committee suggests that this offer be made to any future LOC and/or we consider the \$5,000 to be a grant for hosting the conference rather than a loan.

Save the date! Plans for the 2 - 7 September 2024 joint meeting with TDWG in Okinawa, Japan, are progressing. Okinawa will be the Society's first meeting in Asia and should be an amazing

location! Meetings with the TDWG conference committee regarding the 2024 meeting in Okinawa, have been more frequent, often with multiple meetings within the same week. The Committee is working toward a contract with a conference-organizing company in Japan. Topics to be investigated in further detail are registration cost, administrative costs, account issues, and payment schedules.

The offer to host the 2025 conference at the Yale Peabody Museum of Natural History, New Haven, Connecticut, USA still stands. This would be to a wonderful opportunity to both celebrate the opening of the newly renovated Museum and the 40th anniversary of SPNHC.

There are ideas and rumors of meetings after 2025, but so far nothing solid has come to the Committee. We are also interested in discussing updates to how conferences run, what is expected from an LOC, and the frequency and format of meetings, given the rising costs and financial burden placed on LOCs.



ELECTIONS

This year, the elections were conducted successfully online on platform *ElectionBuddy.com* for second time. The call for nominations was sent via NHCOLL-L on September 22nd, 2022, for the positions of two Members-at-large. There were four candidates nominated for the two positions.

The election began on December 4th, 2022, with a close on January 27th, 2023. All voting members (as of November 2022) were emailed using the online system. At the close of the election, after January 27th, 2023, the total number of returned ballots was 230, or 39.45% of the 583 eligible members.

The bar chart below shows the voting trends over the past six years. With repeated email reminders throughout the election period, the voting turn-out was comparable to 2022.

INCLUSION, DIVERSITY, EQUITY, AND ACCESSIBILITY

The Inclusion, Diversity, Equity, and Access (IDEA) Committee continues to focus on strengthening the Society's goals to create a safe, diverse, and welcoming virtual and physical spaces. Since the 2022 conference in Edinburgh, the IDEA committee worked to compile a handful of simple questions to include in the SPNHC member survey put together by the Long Range Planning Committee. These questions were focused on member funding sources for their positions, as well as open-ended questions that asked members and the general natural history collections community to describe perceived barriers to becoming a SPNHC member and how the Society can become more inclusive. We hope to work off of these responses to inform our next steps.

In October 2022, IDEA Committee members Genevieve Tocci and Ron Eng attended the American Institute of Biological Sciences (AIBS) IDEA Conference 2.0. We want to thank them for representing SPNHC at this meeting. The conference is the second year that AIBS has brought together various scientific Societies to build a movement surrounding diversity and inclusion

issues.

Anna Monfils and Molly Phillips worked with Meghann Toner and Vanessa Delnavaz of the IDEA Committee to have SPNHC representation within a biodiversity sciences career accessibility workshop at the National Museum of Natural History-Smithsonian Institution (NMNH) in April 2023. This workshop was a collaboration between the Smithsonian, Central Michigan University, Biodiversity Literacy in Undergraduate Education (BLUE), the American Society of Plant Taxonomists (ASPT), the Society of Herbarium Curators (SHC), the Botanical Society of America (BSA), the National Science Foundation (NSF) and SPNHC. The workshop took place on April 21st and 22nd, 2023 and provided meaningful networking, hands-on museum collections experiences, and presentations on careers and graduate school to over 80 students.

Moving through 2023, the committee plans to work on an official Code of Conduct for the Society in general and work towards suggestions that come in through the SPNHC member survey. We look forward to working with other SPNHC committees to make inclusion, diversity, equity, and access a foundation for the Society.

LEGISLATION AND REGULATIONS

Of special note is the participation of US Fish & Wildlife Inspector Catherine Yasuda who discussed the intricacies and requirements for the import and export of scientific specimens. Members of the U.S. Customs and Border Protection could not participate in the symposium, but important information about communication with this agency was presented by one of the committee members.

PROFESSIONAL DEVELOPMENT: TRAVEL GRANT PROGRAM SUBCOMMITTEE

The SPNHC Travel Grant Program Subcommittee was established at the 2016 SPNHC Annual Meeting in Berlin. This committee operates under the auspices of the Conference Committee and the Professional Development Committee, with additional input from the Recognition and Grants Committee. The committee also works closely with the Local Arrangements Committee. The first year of operation for the committee was 2017.

Recipients are required to contribute to SPNHC in one of the following ways:

- Recipients are required to contribute to SPNHC in some manner. Ways to contribute included, but are not limited to:
 - Presenting a paper or poster at the 2023 SPNHC conference in San Francisco.
 - Contributing a session/workshop review or report (e.g., a description of a collections management/conservation project or a description of your research) to the SPNHC newsletter.
 - Submitting an article for publication in Collections Forum.

SPNHC members from countries in the following regions were strongly encouraged to apply— Central and South America, Africa, Asia, and Eastern Europe.

There was a total of twenty-six (26) applicants. We had a total of \$1800 for the Fitzgerald grants and \$900 to award for the Christine Allen grant. We awarded two (2) Fitzgerald grants and one (1) Christine Allen grant. We received applications from several underrepresented countries—Chile, Madagascar, Mexico, Norway, the Philippines, and Taiwan.

Meeting mentors will be assigned to those recipients that requested them.

My thanks to the SPNHC members who served as grant reviewers—Rose Basom, Alexandra Coconis, Ron Eng, Austin Hendy, and Cindy Opitz—and SPNHC Treasurer, Theresa Reilly.

A permanent solution to filling the vacancy left by Mariel's departure will be discussed and finalized at the SPNHC 2023 Annual Meeting; an update on this situation will be provided in the October 2023 edition of the society's newsletter, *SPNHC Connection*.

COLLECTION FORUM

Volume 35 of Collection Forum (2021) is now published online at

<u>https://meridian.allenpress.com/collection-forum</u>. This is the first issue to be compiled under our new model of accepting submissions year-round and encompasses manuscripts accepted for publication in the journal following the peer-review process over the years 2021 and 2022. Articles are made available in digital format as soon as final proofs are in place and individual volumes will be closed once a sufficient number of contributions have been published online (generally 6–10 articles), after which the print version will become available. Articles in the most recent issue of *Collection Forum* are available online only to current members, becoming openly available to all once superseded by a subsequent issue.

The current issue hosts five articles on various topics that are now available online with a sixth nearing online publication at the time of this writing, following which the volume will close. Two manuscripts are already in the review process to begin the next volume and will be joined by any new submissions in the near future to form Volume 36.

Immediate access to the online journal's full range of content— and for those members whose subscription level includes it, to periodic print issues—is provided through society membership. In addition to the change in publication mode described above, *Collection Forum* is also now accepting short communications and technical notes as well as certain book reviews and submissions for the *Leaflets* series. Publication as part of the society's official journal will make such material easier to cite, more readily accessible, and increase the content available for publication each year. Editorial review of such submissions and decisions concerning the most appropriate format for publication will be handled in collaboration with the leaflet, book review, and newsletter managers as detailed below.

A revised set of author guidelines for contributors to *Collection Forum* is in development. The new guidelines will cover a broader range of formatting issues, clearly establishing standards for such things as citing publications and outlining more fully the prescribed elements of style for use in journal content. The updated standards will serve to dispel confusion and uncertainty among authors as well as editors, with the hope of also reducing the amount of time spent by both

parties in assessing and finalizing formatting during the publication process.

Members who present at the SPNHC annual meeting are strongly encouraged to submit manuscripts for consideration, particularly those who receive travel awards and support from the society. For inquiries about new submissions, please email the editors at <u>editor@spnhc.org</u>.

US FEDERAL COLLECTIONS

Our first year reorganized has been fruitful. We have strong interest and participation among both repositories and federal agencies. Meeting quarterly, we have discussed ongoing concerns and continue to focus on the following priorities:

- 1. The nature of repository agreements with the different agencies:
 - Examples of current agreements have been shared both from non-federal repositories as well as from our federal partners. Additionally, the chairs have met with members of Department of the Interior (DOI), to understand the larger DOI perspective. (While not governing all agencies, many do fall under the Interior.) Discussions included possibilities of future DOI-wide agreements, task agreements, funding possibilities, and Army Corp. of Engineers survey results. We will continue with these discussions to assist as needed with the hope to facilitate beneficial changes for our collections management.

- Potential sources of funding to support work on federal collections, and Jacob Van Veldhuizen (CUNMH) shared his experience as an example with federal funding for a project that financially supported repositories while meeting targets and goals of the agency.
- 3. Finding ways to make digitized federal collections more discoverable in online databases and data aggregators. Adam Rountrey (UMMP) has been researching Darwin Core (DwC) fields best suited to indicating Federal ownership. Diving into inconsistencies in use patterns and alternatives, he has presented for discussion what might be the manner to best indicate ownership, and at what level, for both use by our federal partners to harvest collections data and researcher's usage to credit appropriately.

Additionally, the committee has allowed for collaboration opportunities to share at other professional societies that could highlight SPNHC's work in the care of Federal collections.

REPRESENTATIVE REPORTS

ALLIANCE OF NATURAL HISTORY MUSEUMS OF CANADA (ANHMC)

In October 2022, the Alliance of Natural History Museum awarded the <u>Bruce Naylor</u> <u>Award</u> to Dr. Reginald Webster in recognition of his significant achievements in the field of natural history in Canada. Dr. Reginald Webster is an entomologist. In more than 100 scientific papers, he has revealed the diversity of Canadian insects, particularly beetles, but also butterflies and mosquitoes. "Dr. Webster has been a New Brunswick Museum Research Associate since 2004, and there is probably no other individual who has contributed so much to our understanding of Maritime insect diversity, both in terms of published work and vouchers deposited in natural history collections," says Dr. Donald McAlpine, Head of the Department of Natural History at the New Brunswick Museum. Dr. Webster has personally documented more than a 1000 beetle species new to Atlantic Canada.

The Alliance's recently formed Climate Change and Biodiversity Loss Committee continues to meet regularly and explore how it can best help its members address these two major planetary challenges. One of the projects being considered is a light travelling exhibit in partnership with government institutions and NGOs where Canadian examples of positives actions towards mitigation of climate change and biodiversity loss (e.g., habitat restoration, nature-based solutions) are presented to our visitors, along with suggestions of actions that would encourage the public to take at home and in their community. More to come...

The Alliance has also joined the <u>KiCulture</u> initiative, a global organization dedicated to creating actionable steps to make culture heritage a leader towards a sustainable future. This provides our members an opportunity to learn from experts in the field the various aspects of sustainability as they relate to museums.

The Alliance of Natural History Museums of Canada (<u>ANHMC</u>;) was created in 2002 from a common desire among directors and senior curatorial staff of Canada's key natural history museums to establish a network for the exchange of information on issues dealing with collections, research and education. The ANHMC seeks to identify issues of common concern, share resources, expertise and experience among its members, speak out with a single voice, and bring the necessary support to collaborative initiatives of the membership.

AMERICAN SOCIETY OF ICHTHYOLOGISTS AND HERPETOLOGISTS

The 2022 Joint Meeting of Ichthyologists and Herpetologists met from 27-31 July in Spokane, Washington at the Spokane Convention Center with lodging at the Davenport Grand Hotel. The meeting was held in person. The symposia were diverse including: Applied, Theoretical, and Technological Advances in Elasmobranch Ecology; Diversity, Equity, and Inclusion in Ichthyology and Herpetology; Biogeography and Diversification of Amphibians and Reptiles of the Pacific Northwest and California Floristic Province; Exemplary Practices in Herpetological Education; The Biology of Whiptail Lizards (Aspidoscelis); and The Utility of Museum Collections for Long-term Ecological Studies and Stable Isotope Analysis. Also, a new, society-wide, effort to make the meetings more "green" (e.g. virtual programs and no conference bags) was implemented at this meeting with great success.

The Ichthyological and Herpetological Collections Committee, co-chaired by Sarah Huber and Jessa Waters, was well attended and discussed many topics. Some of which included the current and future nominations for the Spiritus award, further development of a Google group for collection discussions (<u>https://groups.google.com/group/asih-coll</u>) and future endeavors for the IHCC to consider. Khalil Russell was nominated as the new student representative and he graciously accepted.

AMERICAN SOCIETY OF MAMMALOGISTS (ASM)

Beginning in 1972, the American Society of Mammalogists (ASM) has had a standing committee called the Systematic Collections Committee (SCC), originally formed at the request of the National Science Foundation. The Society has defined this committee's responsibilities as follows: (1) Advising curators worldwide in matters of collection administration, curation, and accreditation; (2) Maintaining a directory of mammal collections and conducting a survey of existing collections once each decade (most recently published in 2018); and (3) maintaining a list of curatorial standards for mammal collections including tissue collections and managing a collection-accreditation program.

The committee has been very active since the Annual Meeting in 2022. The following is a summary of activities:

• Accreditation decisions were made for two collections. The SCC did not grant

accreditation to Arizona State University Natural History Collections, Tempe, AZ but provided recommendations for necessary improvements and suggested reapplication once completed. Secondly, the Committee did not grant accreditation to the National Ecological Observatory Network (NEON) Biorepository at ASU based on status of the biorepository as a project as opposed to a permanent collection. SCC will revisit the application after a proposed update of the *Basic Curatorial Standards for Systematic Collections* (see below) is completed.

- Four collections are currently at various stages of the accreditation process.

 Northern Michigan University provided self-assessment documents and a site visit was performed by Cody Thompson in September 2022. Final disposition of this accreditation is awaiting full committee discussion/decisions. (2) University of Oklahoma, Sam Noble Oklahoma Museum of Natural History provided self-assessment documents and is awaiting a site visit. (3) Colección Regional Durango (CRD), Durango, Mexico provided self-assessment documents and awaits a site visit (Sergio Ticul Alvarez has agreed to be the SCC rep). (4) Arizona Museum of Natural History, University of Arizona, Tucson, AZ provided self-assessment documents and the site visit was performed by Committee members attending ASM meeting in 2022. Final accreditation awaits full committee discussion/decision.
- The Basic Curatorial Standards for Systematic Collections (Journal of Mammalogy, 85:180-181, 2004) is now 20 years old. The Committee will update the document to better reflect current best practices in curation and management and the evolution of NH specimen preservation and use. Specific areas identified as needing attention include: SCC conflict of interest in accreditations; Establishing clear guidelines for what types of collections SCC accredits and what constitutes collection permanence; enhanced definition of professional mammalogist regarding collection oversight; and ensuring guidelines are reflective of diversity, equity, and inclusion issues.
- The committee accepted the resignation of John Hanson and Carl Dick in 2022. We thank them for their many years of service. The committee welcomed two new members: Laura Steger and Rosie Liao, NEON Biorepository, Biodiversity Knowledge Integration Center, School of Life Sciences, Arizona State University.
- Conversion of the Survey and Directory of Mammal Collections of the Western Hemisphere to a digital format hosted on the ASM website was proposed two years. No progress has been made but it remains a collaborative goal for the Systematic Collection Committee and the Informatics Committees.

AMERICAN SOCIETY OF PLANT TAXONOMISTS (ASPT)

With the ongoing war in Ukraine, the Systematics Collections Committee of the ASPT contacted all herbaria in Ukraine to extend our support to the herbarium community and to their families. The Committee has been able to provide financial support to herbaria in Ukraine to either protect their collections in place (as Herbarium at the State Museum of Natural History [LWS] in Lviv) or to move their collections to safer locations [CWU]. In an effort to provide more awareness to the broader herbarium community, the Committee has also been working with the ASPT webmaster to add information about the Herbarium Emergency Fund to the ASPT website.

The annual meeting of the Society is scheduled for 22 – 26 July as part of the *Botany 2023 One World* meeting. Botany 2023 will take place in Boise, Idaho, United States. Similar to previous years, the conference will be a hybrid format, primarily as an in-person event but accompanied by

a virtual option. Symposia and Special Lectures will be presented in person. These presentations will be live-streamed for virtual attendees and recordings available through the online platform to all attendees. Colloquia and Contributed Paper sessions will be both in-person and virtual. Posters will also be presented in person, but presenters have the option to upload their poster to the online platform for the online version of the conference.

BIODIVERSITY INFORMATION STANDARDS (TDWG)

The 2022 annual meeting of Biodiversity Information Standards (TDWG) was hosted by Pensoft Publishers (pensoft.net) in Sofia, Bulgaria, from October 17-21, with both in-person and remote participation. The hybrid conference details can be found at: www.tdwg.org/conferences/2022/. The Interest and Task Group Working Sessions were held virtually November 7-10, focusing on standards development (www.tdwg.org/conferences/2022/working-sessions/). You can check out the abstracts for talks and posters along with the presentations themselves in most cases as they were published as a Proceedings in the journal Biodiversity Information Science and Standards (BISS: biss.pensoft.net/collection/384/). You can also watch many of the presentations via the TDWG YouTube channel (search for TDWG). The virtual environment combined with a low registration fee made TDWG accessible to many who would not normally be able to attend the conference including many SPNHC members!

For those of you who are new to TDWG or are interested in learning more please visit our newly refreshed website featuring our new logo, which is integrated with our GitHub repository (<u>https://www.tdwg.org/</u>). TDWG also manages an open access journal called Biodiversity Information Science and Standards or BISS referenced above. This journal serves two purposes, first to publish the TDWG Proceedings of abstracts for their annual conference, and second, a forum for biodiversity informaticians to publish articles on

biodiversity standards, methods, guidelines, models and applications. If you have content relevant to these topics please consider publishing in BISS. With specific relevance to SPNHC, members of the Natural Collections Descriptions Interest Group have submitted the new "Collections Description" data standard, now called the Latimer Core, for describing collections of natural history materials at the collection level (https://www.tdwg.org/community/cd/), which is now in the review process. Related to this, another task group is developing a Minimal Information about a Digital Specimen (MIDS) standard to more consistently "measure" digitization progress (https://www.tdwg.org/community/cd/mids/). Also, there is increasing discussion and engagement on curation attribution standards (https://www.tdwg.org/community/attribution/). As I continue to stress: "the standards being evaluated by TDWG, and the applications that implement them, have a direct impact on many SPNHC members involved with specimen data capture, management and curation."

In 2023, TDWG is again being realistic in its assessment of COVID-related travel impacts and will hold a hybrid conference with in-person attendance in Hobart, Tasmania, Australia, October 9-13, 2023. For more information please see the conference website (<u>https://www.tdwg.org/conferences/2023/</u>) and consider joining us!

Finally, if you are interested in biodiversity standards, I would urge you to become a member of TDWG and contribute. It takes a wide range of skill sets and knowledge to produce standards and all are welcome.

The collaboration between CETAF and SPNHC continued during the past year. As liaison I was in contact with the chairs of the CETAF ePublishing working group and the CETAF Collections working group.

Continuing previous interactions, members of several SPNHC committees partnered with colleagues of the CETAF ePublishing working group, specifically Laurence Bénichou, Isabelle Gerard and Donat Agosti. Connie Rinaldo from the Biodiversity Heritage Library was an essential and engaged member of the tripartite partnership between BHL, CETAF and SPNHC from the beginning. She passed away last fall and is leaving an empty space that continues to remind us of her. We miss her as individual, fellow traveler and knowledgeable colleague who believed in possibilities.

The spring newsletter already describes in more detail our joint work over the past twelve months. One outcome of our collaboration is the <u>recommendation</u> on best practices for the citation of authorities of scientific names that was published in RIO last September. A second recommendation on extracting data from copyrighted publications that arose from a workshop at TDWG 2022 last fall, organized by BHL, CETAF and SPNHC with expert statements from Willi Egloff (Plazi) and Mariko Kageyama (SPNHC) is in preparation.

In addition to these lines of collaboration, the CETAF ePublishing working group distributed a survey via Nhcoll-I to reach an international audience outside of Europe. Its aim is to understand the landscape of natural science institutions with publication exchange programmes. Its results will be presented at the upcoming CETAF board meeting in Gothenburg, Sweden in May 2023.

Furthermore, Luc Willemse from the CETAF Collections working group and I, together with colleagues from the German Society for Biological Systematics (GfBS) discussed if there is a need for a European convention for collection managers in addition to the existing meetings of SPNHC, NatSCA, ICOM and CETAF. The question is if local or regional opportunities for networking and exchange of expertise are missing specifically for managers, curators and staff involved in collection management, which might be a topic of interest to a wider group of SPNHC members.

CONVENTION ON BIOLOGICAL DIVERSITY (CBD)

The adoption of the <u>Kunming-Montreal Global Biodiversity Framework</u> (GBF) and its monitoring strategy by 196 countries is an important milestone in humanity's response to the biodiversity crisis. Shifting the policy-making baseline and improving the legal context for biodiversity conservation, the GBF has the potential to enable far-reaching changes. SPNHC is an observer organization to the <u>UN Convention on Biological Diversity</u> since 2021 and a more detailed description of the society's involvement in the science-policy process over the past 12 months can be found in SPNHC's spring newsletter 2023.

After a couple of months of breathtaking following COP15 in December 2022, the many processes towards the implementation of the GBF and its monitoring framework are now in full swing. Efforts are led by the Secretariat of the CBD (SCBD), the UN regional groups and the parties (i.e. countries), as well as stakeholders representing many societal groups and acting within a wide range of sectors.

On April 1, SPNHC submitted a <u>contribution</u> to a <u>call by the SCBD</u> for views by parties and stakeholders on issues for consideration by the *Ad hoc Open-Ended Working Group on Benefit-Sharing from the Use of Digital Sequence Information on Genetic Resources* (DSI). The submission was prepared by Dirk Neumann, co-chair of the Legislation and Regulations Committee and myself, and is closely aligned with the contribution by the <u>Consortium of European Taxonomic Facilities</u> (CETAF).

Last week (April 18 to 21, 2023) the <u>World Conservation Monitoring Center of the UN</u> <u>Environment Program</u> (UNEP-WCMC) in collaboration with the SCBD organized a "<u>co-design</u> <u>workshop for a Global Knowledge Support Service for Biodiversity</u>. In addition to representatives of parties and regional groups, as well as UN and CBD bodies, major biodiversity data and tool providers, e.g. GBIF, IUCN, GEO/GeoBon, SANBI, the Asean Center for Biodiversity, attended. Important topics were, among others, interoperability, scalability, linking (of existing resources), federation, (data) governance and mainstreaming – most of these keywords very familiar to us as collections community.

The coming months will be filled with activities as the implementation of the GBF and its monitoring framework is continuing to start up and picking up speed.

The Network is organized and operated exclusively for scientific and educational purposes.

The 2022 annual ECN meeting was held as an in-person and virtual hybrid program in Vancouver, BC Canada in conjunction with the annual meetings of the Entomological Society of America, The Entomological Society of Canada, and The Entomological Society of British Columbia. The in person venue was the Fairmont Waterfront Hotel, 900 Canada PI, in the Waterfront ballroom. Presentations were a mix of in-person and pre-recorded, with all sessions shared via Zoom to keep the meeting as accessible as possible. We began roughly at 08:30 PST/16:30 UTC. Our program co-chairs were Oliver Keller and Jennifer Girón.

The final count was 203 (in person) and 87 (virtual) registrants. There were 24 talks and two symposia (*Collections of the World* (13 represented collections featured) and Latin American Collections Online (7 presentations). There were also 10 posters presented. participants from at least 17 countries.

GLOBAL BIODIVERSITY INFORMATION FACILITY (GBIF)

SPNHC is an organizational Associate Participant in the Global Biodiversity Information Facility (GBIF). James Macklin is the current GBIF "Head of Delegation" for SPNHC and also serves as the Canadian Node Manager. The 29th Annual GBIF Board Meeting took place in Brussels, Belgium, October 2-6, 2022. There were many valuable updates presented on the core work in which GBIF is currently focused (<u>https://docs.gbif.org/2023-work-programme/en/</u>), including the approval of their next Strategic Framework covering 2023-2027 (https://www.gbif.org/document/50II7Bxn2p1vRgpbs7aXaT/gbif-strategic-framework-2023-2027).

GBIF continues to promote the digitization and mobilization of biodiversity observation data and provide support through making available a wide variety of tools, best practices and documentation. In addition, if you have not looked at the country-level information pages, I encourage you to do so as they can be very informative. Numerous opportunities are available for training at various scales as well as competitions for funding to develop new tools and methods for data mobilization, quality control, and dissemination. I encourage all members to get involved and support this critical organization.

Of note, GBIF continues to actively investigate ways to diversify its current data model to support richer, more complex types of biodiversity data

(https://www.gbif.org/fr/composition/HjlTr705BctcnaZkcjRJq/data-model-principal-

<u>composition</u>). They have run several webinars explaining the proposed model, including one on implications for collection management systems. GBIF is currently very interested in feedback on the model based on the use cases they have considered as well as being interested in testing additional ones. To encourage this they had an open call offering small grants to a diversity of groups interested in attempting to model components of their data. If you are interested in having a custom site to showcase your data, you might consider a GBIF-hosted data portal. Several pilots based on regions and themes were generated as part of a set of pilot projects with some now in production (<u>https://dev.gbif.org/hosted-portals.html</u>). Work also continues on the Global Registry of Scientific Collections or GRSciColl (<u>https://www.gbif.org/grscicoll</u>). The main goals are to "improve access to information about scientific collections, their host institutions as well as contacts for key collections and curatorial staff" and "improve interoperability among databases by providing unique codes and machine-readable identifiers for institutions and collections."

Lastly, a reminder for all to support GBIF and the biodiversity informatics community's unified vision to globally coordinate biodiversity-based resources and infrastructures. This continues to be discussed more broadly through the formation of "<u>An Alliance for Biodiversity Knowledge</u>".

In 2022, the United States had 18 natural disaster events with losses that exceeded more than one billion dollars each. Flooding posed the most significant threat causing 100's of human deaths and extensive damage to cultural heritage sites. HENFT, working in tandem with SCRI, strove to protect cultural and historic resources in our nation's states, tribes, territories, and local communities from the damaging effects of disasters. In addition to assisting museums and other cultural institutions when their collections were damaged by an event, HENTF and SCRI helped reduce disaster suffering by sending personnel to assist the public in salvaging family treasures and heirlooms. INTEGRATED DIGITIZED BIOCOLLECTIONS (iDigBio)

Integrated Digitized Biocollections (iDigBio) serves as the coordinating center for the U.S. national digitization effort funded by the U.S. National Science Foundation (NSF <u>2027654</u>). As of 2021, iDigBio also includes the Symbiota Support Hub, a service team and infrastructure resource for Symbiota portal users and contributors (<u>https://symbiota.org/</u>). Katie Pearson, the project manager for the Symbiota Support Hub, is the new iDigBio liaison for SPNHC.

iDigBio has been hard at work in 2022 to serve the biodiversity collections community by fostering partnerships and innovations, facilitating development and sharing of digitization practices and workflows, and promoting the uses of biodiversity collections data by stakeholders. We work to help collections communities get digitization done efficiently and collaboratively and to make the data available according to <u>FAIR principles</u>.

We have added 3 staff members (Shyla Davison, EODI Coordinator; Jesse Grosso & Lauren Cohen, Deputy Project Managers) to enhance our services to the collections community. iDigBio staff and PIs have provided leadership for the SPNHC Biodiversity Crisis Response Committee, including hosting internationally-attended workshops and symposia at the SPNHC conference. Last September's virtual BioDigiCon conference, which focused on digitization activities and practices, attracted more than 1100 participants from 68 countries. We have worked closely with the SPNHC Best Practices committee to improve digitization and data management documentation on the SPNHC Best Practices wiki. We have coordinated numerous online events and webinars including monthly <u>Symbiota Support Group</u> meetings, biweekly <u>Paleo Data Happy Hours</u>, <u>Symbiota Portal Campaign</u> trainings and community meetings, data quality webinars, and more.

Along with several co-sponsors, including SPNHC, iDigBio is organizing and planning the development of several webinars, workshops, and online community consultations focused on envisioning the Biological Collections Action Center as proposed in the <u>NASEM report</u>. Several iDigBio staff and PIs have been collaborating closely with the Biological Collections Network (BCoN) and its International Partners Group on conceptualizing the implementation of the Digital Extended Specimen, an important recommendation from the recent BCoN report.

MANAGERS OF AUSTRALASIAN HERBARIUM COLLECTIONS— COUNCILS OF HEADS OF AUSTRALASIAN HERBARIA (MAHC-CHAH)

With CHAH (Council of Heads of Australasian Herbaria), the <u>Australasian Systematic Botany</u> <u>Society</u> (ASBS), and the <u>Australian Biological Resources Study</u> (ABRS) turning 50 this year, the Managers of Australasian Herbarium Collections (MAHC) are helping to organize training sessions to be held in conjunction with conferences later in the year. Members are also working on several standard document templates for accessioning and acquisition, information for visitors, and material transfer agreements, to complement the documents already available on the <u>CHAH</u> <u>website</u> for use by Australasian herbaria – and freely available for modification and use by others. MAHC members were involved in User Acceptance Testing (UAT) for the Restricted Access Species Data Service being developed, which will ultimately be used to provide secure access to sensitive species data in Australia. Members were also involved in a 2-day workshop to help explore and define the key components needed to shape a National Approach to Collections as part of the Australian <u>National Research Infrastructure Roadmap</u>.

Preliminary discussions have taken place to consider the feasibility and appetite for hosting a SPNHC conference in Australia in the future.

Herbaria in Australia have recently been experiencing issues with the entry of parcels into Australia. The quarantining of parcels by the Department of Agriculture, Fisheries and Forestry results in an extra cost to herbaria, incurring a quarantine entry fee. We remind our SPNHC colleagues to please contact Australasian herbaria directly before shipping parcels to ensure that you have the latest shipping instructions and documentation. Please also email all documents to the receiving institutions before shipping to streamline any quarantine issues.

The next meeting of The Paleontological Society (PS) will be held during the Geological Society of America (GSA) meeting in in Pittsburgh, Pennsylvania October 15–18, 2023.

The PS Collections Subcommittee organized a topical session, "From Field to Repository: Addressing Theoretical and Practical Issues in Paleontological Collecting and Collections," as part of the technical program during GSA 2022 in Denver. The session focused on successes and outstanding issues associated with fossil collections and collecting on private, federal, and tribal lands by professionals and amateur paleontologists; preserving physical and digital fossil data post-collection; and consistent, effective stewardship of fossils and repositories. The session was very well received, and the Subcommittee hopes to follow this with a more in-depth short course on collecting and collections at a future GSA meeting.

The PS Collections Subcommittee also created a survey that was rolled out at GSA 2022. The purpose of the survey was to better understand professional and avocational paleontologists' views on fossil collecting and collections. The responses to the survey will be used to inform and guide the activities of the Subcommittee going forward. We hope to better meet the needs of the broad community of invertebrate and vertebrate paleontologists and micropaleontologists and paleobotanists.
