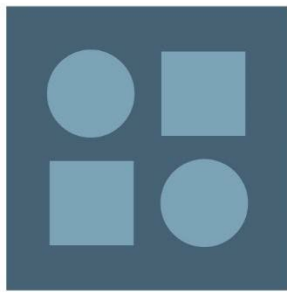

THE FABER INNOVATION GRANT:

The Faber innovation grant is a cash grant for an original proposal, intended to encourage innovative projects that promote the objectives of the Society in collections management, conservation, use or other collection-oriented aspects of natural history. The Society awards the Faber Innovation Grant of \$1000 to Jay Cordeiro to develop initiatives to enable the wider utilization of the natural history collection at Bridgewater State University (BSU).

THE EARLY CAREER AWARD:

This award is presented to a member who is at an early stage in their career, or at an early stage in their involvement with SPNHC, and who has demonstrated great potential for leadership through innovative and energetic service that strengthens and broadens the impact of SPNHC. Awarded to Megan King, for her involvement in the strategic plan committee and chair of NC/DC.

The PRESIDENT'S AWARD:

This award is for superior service to the Society. Normally, this would involve exceptional service to appointed offices, committees, and/or ongoing activities of SPNHC. This year's recipient is no stranger to the Society and to most of its members. This person has organized dozens of workshops and symposia and served on committees and in advisory roles on grants. The recipient is a prolific author and is constantly striving to improve standardization and best practices in digitization and, in fact, is the director of iDigBio. The recipient of the 2025 President's Award is Gil Nelson.

The CAROLYN ROSE Award

The Carolyn L. Rose Award is our Society's highest honor and given to a *practitioner*, whose work and efforts have promoted the values and objectives of the Society. This award is not given annually. In fact, it has only been awarded 9 times in the Society's history. This year we celebrate the 10th! This year's recipient has had a career in natural history collections spanning more than 40 years and has served many roles for the society, including serving as treasurer, Member-at-large, President (6-year tour) and 12 committees! Report of the Treasurer

In 2025, the Society's total net assets decreased to \$490,339. from a total of \$492,663 the previous year. Liabilities and net assets for 2025 totalled \$470,128 Operating income was generated from two sources: membership dues and publication sales.

A total of \$ 26,890.00 in membership dues was received through October 2025. Sales of our seven publications plus royalty payments brought in \$3,177. A total of \$4,000 was received from the first Art Auction for Travel Grants at the 2025 SPNHC Conference.

Of the 796 SPNHC members in 2025, 397 joined for the first time. New memberships included 81 students, 118 are institutional, and the remainder are individual.

The first part of 2026 has seen steady income activity and by June 30th \$27,757 has been received from membership dues. We have welcomed 82 new members of which 15 are student memberships, 38 are institutional, and the remainder are individuals.

As a reminder, we ask that all members please pay your dues on time.

The Treasurer's Office incurred \$42,855 in expenses which included \$3,360 for insurance, \$2,604 for Zoom, \$6325 for Tax Preparation Services, \$23892.84 for the Christy Classi contract and \$780 for the annual fee for QuickBooks.

Long-term investment funds were consistent with the market; SPNHC investments saw a slight market value loss of \$44.53. while the money market account earned \$8,899.65 in dividends and interest. CD account earned \$930 in interest.

The Society anticipates expenses related to signed contracts, insurance premiums, tax payment and membership renewals for the remainder of 2026.

The 2025 financial review is being prepared by the auditor and will be provided when completed.

BEST PRACTICES

BIODIVERSITY CRISIS RESPONSE

Three meetings were held online between the February 2026 Report and the submission of this report, in February, April and July. For more details see <https://docs.google.com/document/d/1URtds97edUvtu7XYqvLrG45zBa-pYblqFJaUPJPtu80/edit?usp=sharing>.

The main output has been the webinar Contributions of Natural History Collections to Conservation. This was run in two sessions on the 18th and 20th May, in each session three speakers gave talks. Details can be found in the dedicated website - <https://collectionsforconservation.org/>

In summary, in the first session Anabela Plos spoke about Data dissemination of global biodiversity followed by Francisco Morales on Small herbaria in the Americas and their contribution towards conservation and it concluded with Jordan Teisher on 40 Years of Botanical Data (in 15 Minutes) – Tropicos, Conservation, and the Missouri Botanical Garden. The second session started with Michelle Price presenting on Promoting natural history collections and access to them: the importance of the community, collaborations, networking and exchange followed by Andrea Weeks with Advancing conservation in the Anthropocene by linking collectors to their natural history specimens using Bionomia and concluding with Tuntiak Katan with Protection and conservation of the biodiversity before it becomes a natural history collection, the role of Territorial Communities.

The recordings will be uploaded to YouTube and the link to them will be sent as soon as they are ready. Regarding attendance the numbers were:

Day 1: 41 attendees (out of 97 registrants), 17 countries (Argentina, Bolivia, Brazil, Chile, Colombia, Ecuador, Germany, Japan, Lithuania, Mexico, Peru, Philippines, South Africa, Sri Lanka, Switzerland, United Kingdom, United States).

Day 2: 24 attendees (out of 100 registrants), 11 countries (Argentina, Brazil, Colombia, Costa Rica, Ecuador, France, Philippines, Spain, Sri Lanka, United Kingdom, United States)

To continue the theme of the webinar a session will run at the SPNHC Cape Town 2026 conference under the same title. Currently five speakers from Kew London and Madagascar, Tulane University, Durban Natural Science Museum and Iziko Museums are lined up to present in person, speaking about how their collections of plants, insects, freshwater fish and bats are being used in conservation work.

Going forward, although some members of the BCRC will be attending the meeting in Cape Town in person, Alina will not be attending, and Mike will only be there virtually.

CONFERENCE

With the new conference guidelines in place and conference and sponsorship coordinator, Ruth Seyler we have made great progress with confirmed and prospective conference hosts for the coming years. Special thanks to Ruth for her expert advice, diligence, and guidance. Her support and thoughtful approach have been greatly appreciated and has made a significant contribution to the committee's work.

2026 – Cape Town, South Africa Working with our hosts at Iziko Museums South Africa the joint organizing committee made up of Ruth Seyler, Greg Watkins-Colwell, Andy Bentley, Suzanne Ryder and the local organizing committee, Wayne Florence, Adriaan Jordaan, Romala Govender we have prepared an engaging technical programme and a wonderful programme of events and in Cape Town for September this year. This will be the first SPNHC conference in Africa and the theme of the conference is appropriately *Bridging Hemispheres: Collaborating for a Unified Natural Heritage*.

2027 – Montreal, Canada We are correctly working with a consortium of likeminded organizations to organize a joint conference in Montreal next summer. Establishing partnerships with these organizations will facilitate networking and collaborative opportunities with stakeholders that share common strategic objectives, fostering the exchange of knowledge, expertise, and best practice to support the achievement of mutual goals. The partnership joining SPNHC will be Biodiversity Information Standards (TDWG), the Group on Earth Observations Biodiversity Observation Network (GEO BON), the Québec Centre for Biodiversity Science (QCBS), and the International Barcode of Life Consortium (IBOL). This opportunity came about after having two offers of interest from Edmonton and Montreal for the 2027 SPNHC conference. It transpired that TDWG were also looking to have their conference in Montreal that year, so it made sense to combine forces rather than compete for delegates. The conference committee are currently working through the MOU, once this has been agreed and signed by all partners we can move forward in earnest.

2028 - University of Illinois Urbana-Champaign, Illinois, U.S.A. Ruth has been working hard with our host Enrique Santoyo-Brito in Illinois for the conference in 2028. The preparation for that meeting is going well. We are currently waiting for approval by the Director of the university before proceeding further with the planning process.

We are constantly working on the conference calendar for SPNHC going forward and will send out more information when we have confirmed details for the conference venues for 2027 and 2028. If you and your institute are interested in hosting the SPNHC conference, please contact anyone on the conference committee, we would be delighted to discuss any opportunities and possibilities.

The objectives for the coming year are to:

- Deliver an engaging, memorable, and cost-effective first SPNHC conference to be hosted in Africa, in partnership with the Iziko South African Museums Local Organizing Committee (LOC). The conference will provide an exceptional experience for all participants while fostering meaningful networking, collaboration, and

knowledge exchange among the global natural history collections community.

- Secure a MOU with the partner organizations for the 2027 SPNHC conference and work with them to plan a relevant and appealing joint meeting.
- Work with the prospective host for 2028
- Make enquiries for a suitable venue for 2029 and subsequent conferences.
- Work to implement the goals and objectives of the SPNHC strategy.

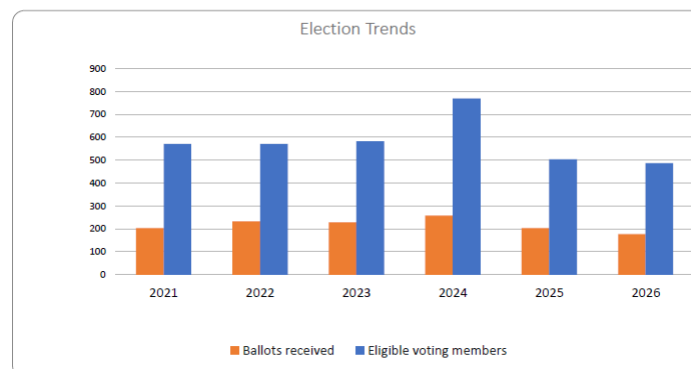

FINANCE

INCLUSION, DIVERSITY, EQUITY, AND ACCESSIBILITY (IDEA)

LEGISLATION AND REGULATIONS

The recent removal of the De Minimis Treatment of imports into the United States and the European Union, eliminating the low-value exemption for all shipments, has required major adjustment to the electronic systems used by national postal services and international carriers. In advance of these changes, the Legs and Regs Committee disseminated information through NHColl to inform our members and community. However, these adjustments have also created new challenges for the international shipment of scientific loans. During import clearance, the electronic systems often lack the capacity to capture the detailed information needed to accurately identify and process scientific loan material needed to convey correct information into customs systems, resulting in delays and other clearance issues.

The Legs and Regs Committee successfully organized a meeting with the FedEx International Headquarters in Nashville, Tennessee, USA, on September 30, 2025, to address shipping issues affecting our community. The meeting resulted in the resolution of a specific shipping issue associated with Australia and New Zealand, and it provided an opportunity to develop two resources, which were subsequently shared with our contacts at FedEx International Headquarters. The first resource is a guidance document outlining best practices for shipping natural history specimens via FedEx. The second presents recommendations for improving customs clearance procedures by addressing three key challenges encountered when shipping natural history specimens internationally: (1) the limited capacity of the Item Description field to accommodate customs-relevant information; (2) the misclassification of scientific specimens within the FedEx E-Declaration system; and (3) the absence of an

appropriate customs documentation category for scientific specimens. These recommendations were also presented during a follow-up meeting in July with FedEx Germany, a major international air hub responsible for the processing and dispatch of European shipments. We look forward to continuing discussions with FedEx representatives to explore opportunities for implementing these recommendations and improving customs clearance procedures for the international shipment of natural history specimens.

In December, the committee informed the SPNHC members about the open call of the CBD Secretariat to participate in a survey on decision NP-3/1, paragraph 18 (a), intending to improve some of the dysfunctionalities of the Nagoya Protocol. Our committee prepared a PDF template of the survey and invited active participation of individual SPNHC members via NHCOLL-L. The Legs and Regs Committee also participated in an independent survey of the CBD secretariat, representing SPNHC as a relevant stakeholder to the CBD.

The Legs and Regs Committee is currently monitoring developments related to the Agreement under the United Nations Convention on the Law of the Sea on the Conservation and Sustainable Use of Marine Biological Diversity of Areas Beyond National Jurisdiction (BBNJ Agreement), which was adopted on June 19, 2023. The Agreement applies to Marine Genetic Resources collected from waters outside any single country's jurisdiction (the high seas). As the Agreement continues to be ratified and implemented by countries around the world, it introduces new reporting obligations for specimens collected during research cruises on scientific vessels, as well as for institutions that hold and provide access to Marine Genetic Resources. The committee will continue to monitor these developments and keep the SPNHC community informed of any implications for natural history collections and their associated research activities.

LONG-RANGE PLANNING

The Long-Range Planning Committee is responsible for understanding the processes and actions needed to achieve the strategic goals of the Society for the Preservation of Natural History Collections (SPNHC). It also determines what is needed to develop and progress SPNHC whilst responding to a changing environment, the needs of its membership and the wider natural history collections community. The committee ensures that strategic planning supports the activities, and guides the direction and sustainability, of SPNHC. This year we have been reviewing the progress the Society and its committees have made towards the goals and objectives set by the current Strategic Plan, 2025-2035. A review document has been created and shared for comment with the wider LRP committee members. The aim is to highlight the areas that need attention in the coming year, and which goals are on track.

This strategic review has demonstrated that many of the goals and objectives set out in the Strategic Plan (dates) are already being effectively delivered through the sustained and substantial efforts of the SPNHC committees.

Another significant area of work being undertaken by the LRP and membership committee is a review of the partnerships with other professional societies and associations formally in place with SPNHC. We are reviewing their mandate, role, and relationships to make sure they are current and continue to be beneficial to both parties, with active representatives and liaisons. We have sent out letters to all our current collaborative partners and are collating the responses. The results will be reported to Council in the coming months. This exercise has been interesting and one that clearly needs further work and consideration. Many of the MOU's are very old, some organizations do not have a current liaison, but the renewed communication for other organizations has already proved fruitful. I would like to suggest to Council that this work be continued with a designated MAL over the next year.

The objectives for the coming year are to:

- Report on the evaluation of the Strategic Plan review to council.
- Meet with the committee chairs to highlight the work needed to achieve specific strategic objectives and goals and assist where needed.
- Produce a report for council after reviewing current partnerships SPNHC has in place to make sure they are up to date and continue to be beneficial to both parties.
- Using the findings of the partnership report working with a designated MAL to implement the suggestions of

the report.

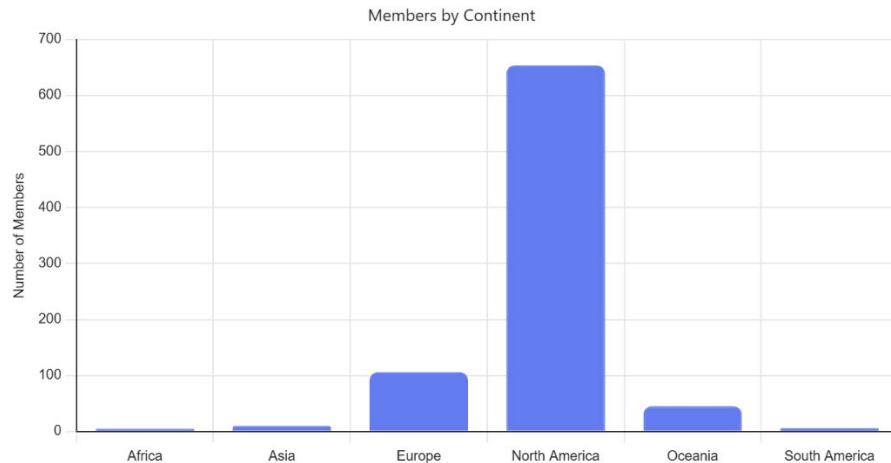

While the overall geographic distribution of members remains broadly similar to previous years, the Society

continues to maintain a genuinely international membership, with members represented in 31 countries across all six inhabited continents. Gains have been made since the start of the membership year in regions that have historically had lower representation, including Africa, Asia and South America. Although these regions still account for a relatively small proportion of total membership, the presence of members from every continent demonstrates the Society's growing global reach and provides a strong foundation for future diversity and international engagement initiatives.



Collaborative Partnerships

SPNHC maintains strong relationships with organizations that share our commitment to advancing natural history collections. During the year, the Membership Committee contacted 25 collaborative partners to reaffirm these connections, confirm liaison contacts, and explore opportunities for future collaboration.

Partners were invited to share updates on their activities, suggest new ways of working together, and identify opportunities for joint training, professional development, workshops, and meetings. Responses are currently being collated and analyzed, and the feedback received will help guide the continued development of these important and mutually beneficial partnerships.

US FEDERAL COLLECTIONS

The US Federal Collections Committee continues to work towards building connections between federal agencies and non-federal organizations to increase collections accessibility and streamline the management of federal collections by non-federal repositories. We thankfully have continued productive conversations and keep communications open with our federal partners.

While much of our discussion in the past year was focused on navigating the changing state of affairs during federal shutdowns and the unfortunate impact of RIFs (Reduction in Force), our committee also held meetings discussing a range of topics including international shipment of federal specimens, orphaned collections containing federal objects, updates on RAPTOR (the BLM's new online permitting and report system), and the state of agreements and contracts with federal agencies.

A subset of our committee has been working to increase the discoverability of federal specimens. We have begun crafting recommendations for usage of certain Darwin Core terms as well as moving towards a best practice recommendation for non-federal institutions on denoting the ownership of federal objects held in their collections. We have also reviewed standard ownership vocabulary for different federal agencies and sites. This is a work in progress and a continued focus for the committee for the remainder of the year.

We encourage anyone interested in the management of US federal collections to join our committee and help foster these productive discussions.

SESSIONAL COMMITTEE REPORTS

CALIFORNIA COLLECTION PROJECT GRANTS

Through the kind generosity of the California Institute for Biodiversity and the State of California, the Society for the Preservation of Natural History Collections (SPNHC) was granted US\$372,277 in funding to award in support of saving at risk collections relating to the geographical area of California. The funding was available to rescue specimens and samples, process backlogs and accession specimens, repair collections infrastructure, and otherwise secure biodiversity specimens and associated materials and data.

The California Collections Project Grants have been a very successful program for SPNHC. The committee received 32 applications for funding, from which 14 grants were awarded to successful applicants. Of the 14 grant projects 12 have now been completed, listed below:

- Cal Poly Humboldt - Rescuing Specimens, Strengthening Infrastructure: Accessioning and Maintenance of the Cal Poly Humboldt Fish Collection
- The Regents of the University of California, UC San Diego - Rescue of the Station M collection of California deep-sea invertebrates
- Yale Peabody Museum - Housing and Databasing the Noll Collection of California Insects at the Yale Peabody Museum
- The Regents of the University of California, Santa Barbara - Critical Care for Central Coast Herpetology Collection
- Academy of Natural Sciences of Drexel University - Safeguarding California's fossil heritage in the US's oldest invertebrate palaeontology collection
- The University of Iowa Museum of Natural History - Securing California Aquatic Invertebrates at the University of Iowa Museum of Natural History
- Carnegie Institute/Carnegie Museum of Natural History - Securing Carnegie's Specimens of the Californias
- Turtle Conservancy - Turtle Conservancy - Resurrecting the Scientific Collection of Dr. Peter Pritchard
- Petaluma Wildlife Museum - Museum Curation Starts at Any Age: Teaching High School Students Museum Collection Stewardship
- Illinois Natural History Survey Insect Collection - Securing California Arthropod specimens in the Illinois Natural History Survey Insect Collection
- Natural History Museum of Los Angeles County - Twice Salvaged: Conserving Orphaned Mitigation Palaeontology Resources
- California Academy of Sciences - Curation of Cal Poly San Luis Obispo fish collection

Some projects requested a no-cost extension, and 2 remain to be completed or submit their final reports:

- San Diego State University - Saving the Chen Fish Collection and training the next generation of collections workforce
- UC Davis Center for Plant Diversity Herbarium - Lassen Herbarium Rescue

We are honoured to have been able to facilitate the award of this grant money to some many organisations within the SPNHC network. We hope that the grant funding assisted in providing much needed collection care and supported new roles for emerging professionals to gain hands on experience workings with collections.

AMERICAN SOCIETY OF MAMMALOGISTS (ASM)

Beginning in 1972, the American Society of Mammalogists (ASM) has had a standing committee called the Systematic Collections Committee (SCC), originally formed at the request of the National Science Foundation. The Society has defined this committee's responsibilities as follows: (1) Advising curators worldwide in matters of collection administration, curation, and accreditation; (2) Maintaining a directory of mammal collections and conducting a survey of existing collections once each decade (most recently published in 2018); and (3) maintaining a list of curatorial standards for mammal collections including tissue collections and managing a collection-accreditation program.

The following is a summary of activities since the Annual Meeting in 2025:

- 1) No collections were accredited or reaccredited this year.
- 2) Three collections remain at various stages of the accreditation review process.
 - a. Denver Museum of Nature and Science
 - i. Planned site-visit during ASM 2024 annual meeting was postponed
 - ii. Pending scheduling of new site-visit
 - b. University of Oklahoma, Sam Noble Oklahoma Museum of Natural History
 - i. Requested accreditation of genetic resources collection in March 2020
 - ii. Underwent staffing changes which affected scheduling of with SCC visit
 - iii. SCC chair contacted current staff regarding reinitiating the process
 - c. Museo Javeriano de Historia Natural-MUJ, Pontificia Universidad Javeriana of Bogotá
 - i. Made initial inquiry into accreditation
 - ii. Received self-assessment documents from chair (15 March 2024)
 - iii. No further contact to date
- 3) A new survey of South American collections was published in 2025 (Weksler, M., D'Elia, G., Teta, P., et al. 2025. A comprehensive survey of mammal collections and genetic resources in South America: challenges and directions. *Biological Journal of the Linnean Society* 146(1), p.blaf069).
- 4) An updated list of accredited collections is complete and will be available on the ASM SCC website.
- 5) A guideline document for performing accreditations will be completed and available on the SCC website soon.
- 6) A revision of the Basic Curatorial Standards for Systematic Collections (*Journal of Mammalogy* 85:180-181, 2004) is in process. A final document will be available for President and Board of Directors review prior to the 2027 annual meeting. The Standards document will be submitted to the journal for publication shortly thereafter.
- 7) Conversion of the Mammal collections of the Western Hemisphere: a survey and directory of collections into a digital format hosted on the ASM website was approved by President Smith but development has stalled. A SCC subcommittee (Kurt Galbreath, Katrina Derieg, Cody Thompson, Nate Upham and Jon Dunnum) and the

communications Committee remain tasked with initiating this project.

8) The committee had no turnover of members this year.

9) Jonathan Dunnum stepped down as Chair at the end of the 2026 meeting. Cody Thompson assumed the Chair position at that time.

AMERICAN SOCIETY OF PLANT TAXONOMISTS (ASPT)

The American Society of Plant Taxonomists (ASPT) continues to advance its mission of promoting research, education, and collaboration in plant systematics and floristics. Over the past year, ASPT has strengthened its role as a hub for professional exchange, student support, and the dissemination of high-quality taxonomic research.

ASPT's professional development and community-building efforts saw notable growth this year. The Society expanded its virtual and hybrid programming, providing new avenues for members to engage with emerging methodologies in phylogenetics, biodiversity informatics, and botanical collections research. A series of member-led webinars and discussion panels attracted broad participation, fostering dialogue across institutions and career stages. The ASPT Wiki and online resources continue to be refined and updated, offering practical guidance ranging from best practices in herbarium management to teaching tools in plant systematics.

ASPT's flagship publication, *Systematic Botany*, published 30 high-impact research articles spanning taxonomy, phylogenomics, biogeography, and nomenclature across four issues.

The Botany 2026 conference—held jointly with the Botanical Society of America (BSA) and other partner societies—is occurring August 1-5, 2026 in Tucson, AZ (with a hybrid option to maximize accessibility). ASPT-sponsored symposia, workshops, and field trips will highlight topics such as integrative taxonomy, digitization and data mobilization, advances in phylogenomic pipelines, herbarium-based discovery, and conservation-driven floristics. The ASPT Student Section will have expanded mentorship events, including networking sessions and a research-in-progress forum designed to support students and early-career researchers.

ASPT looks forward to another productive year of collaboration, scientific discovery, and community support as it continues to champion the study and understanding of plant biodiversity.

BIODIVERSITY INFORMATION STANDARDS (TDWG)

The 2025 annual meeting of Biodiversity Information Standards (TDWG) was held jointly with the Group on Earth Observations Biodiversity Observation Network (GEO-BON), the Ocean Biodiversity Information System (OBIS) and the Global Biodiversity Information Facility (GBIF) under the unifying "Living Data" conference held in Bogotá, Colombia from October 21st-24th. The hybrid conference details can be found at: <https://livingdata2025.com/>. You can check out the program, read the abstracts, and can watch many of the presentations via the TDWG YouTube channel (search for TDWG). This was a great opportunity for four critical biodiversity communities to learn from each other! This year the Interest and Task Group Working Sessions were held virtually from the 11th to 22nd of May (2026) focusing on standards development.

For those of you who are new to TDWG or are interested in learning more please visit our website, which is integrated with our GitHub repository (<https://www.tdwg.org/>). TDWG manages an open access journal called Biodiversity Information Science and Standards or BISS. This journal serves two purposes, first to publish the TDWG Proceedings of abstracts for their annual conference (done for select abstracts in 2025), and second, a forum for biodiversity informaticians to publish articles on biodiversity standards, methods, guidelines, models and applications. If you have content relevant to these topics please consider publishing in BISS (<https://biss.pensoft.net/>). With specific relevance to SPNHC, members of the Natural Collections Description Interest Group have recently completed work on the ratified "Collections Description" data standard, now called

the Latimer Core, for describing collections of natural history materials at the collection level (<https://lhc.tdwg.org/>). Likewise, the Minimal Information about a Digital Specimen (MIDS) standard was ratified, which more consistently “measures” digitization progress (<https://mids.tdwg.org/>). There was also a suite of new terms added to DarwinCore based on the alignment with GBIF’s new conceptual data model and implementation of the new DarwinCore Data Package protocol (<https://gbif.github.io/dwc-dp/qrg/index.html>). As I continue to stress: “the standards being evaluated by TDWG, and the applications that implement them, have a direct impact on many SPNHC members involved with specimen data capture, management and curation.”

In 2026, TDWG is excited to return to Europe and meet in Oslo, Norway from September 21st to 25th. The theme for the conference is “Research and Robot-ready Biodiversity Data Standards.” For more information please see the conference website (<https://www.tdwg.org/conferences/2026/>) and consider joining us!

Finally, if you are interested in biodiversity standards, I would urge you to become a member of TDWG and contribute. It takes a wide range of skill sets and knowledge to produce standards and all are welcome.

CONSORTIUM OF EUROPEAN TAXONOMIC FACILITIES (CETAF)

As SPNHC’s liaison to the Consortium of European Taxonomic Facilities (CETAF), I maintained engagement under the Memorandum of Understanding (MOU) between SPNHC and CETAF throughout the past year. Points of connection between the two organizations include my continued active membership in the CETAF ePublishing Working Group. Dirk Neumann co-chairs both SPNHC’s and CETAF’s respective working groups on Legislation and Regulations. Recent discussions among Dirk Neumann, Suzanne Ryder as SPNHC’s incoming president, and myself explored collaborative training options involving CETAF, the CBD, and SPNHC. Connections to CETAF’s Collections Working Group seem currently suspended, as this group is in transition and awaiting new leadership.

Beyond these activities, I am not in a position to report on the fuller range of joint activities that may exist between SPNHC and CETAF under the MOU, as I do not have visibility into them. This raises a question similar to the one I have raised in my CBD report: how much of the engagement conducted under SPNHC’s various partnerships is actually reaching SPNHC or its partner organizations, or strengthening the relationships these partnerships are meant to establish and serve? Structured work routines for regular discussion and coordination between liaisons, representatives, and SPNHC’s leadership do not currently exist — a gap that may be worth the society’s attention, independent of any single partnership.

CONVENTION ON BIOLOGICAL DIVERSITY (CBD)

As SPNHC’s representative to the UN Convention on Biological Diversity (CBD), I maintained close engagement with the CBD and its partners throughout 2025 and 2026, tracking policy developments relevant to global biodiversity conservation.

During the second half of 2025, I attended one webinar organized by the Secretariat of the CBD (SCBD) and 16 by global organizations (e.g. IPBES, OECD, etc.) and the wider network of CBD partners, including the DSI Network, COOP4CBD, etc. In 2026, I have attended five webinars organized by the SCBD and seven webinars by global organizations and CBD partners. Financial and socio-economic sustainability and resilience emerged repeatedly across this engagement as a major theme, not only for human societies worldwide but also for the bio/geodiversity collections — material and digital — and their services community. This observation prompted me to pursue further training on my own initiative: I completed BIOFIN’s massive open online course, “Biodiversity Finance: Designing and Implementing Finance Plans for Nature,” earning the certification in November 2025, and a further certification on biodiversity credit systems in June 2026.

Despite the currently disconcerting geopolitical atmosphere, activities toward implementing the Kunming-Montreal Global Biodiversity Framework (KM-GBF) are moving forward at speed. Given that the UN system and large multilateral organizations are often considered slow to respond and cumbersome in their decision processes, this progress might even be called remarkable. For me, the engagement with the CBD and associated global stakeholders has been a major source of optimism and hope: I have experienced the sustained engagement of party delegations and observer organizations, the steady development and roll-out of KM-GBF monitoring by the CBD and its partners, and the surge of associated processes triggered by its adoption, e.g., in biodiversity finance and nature-positive economics, national monitoring, data infrastructure interoperability and governance, and gender awareness and gender-responsive data disaggregation. Independently, yet in alignment with my SPNHC partnership role, I am contributing to a collaboration initiated by the GEO BON Genetic Composition Working Group, which aims to "systematically evaluate the extent and quality of genetic diversity conservation commitments in National Biodiversity Strategy and Action Plans (NBSAPs)."

Given how little of this engagement has been explicitly tied to my formal role, and how few channels exist for information to flow back, I find myself asking: have any insights and outcomes of these activities reached SPNHC at all? Taking a systems view, being a partner to the CBD, and engaging for global biodiversity conservation, intrinsically requires organizations and people to change and to accept transformation — this is what the KM-GBF is fundamentally about. This holds true even for a volunteer organization like SPNHC, engaging as fully as it can. Such transformation, in turn, requires leadership that is willing and able to embrace change, rather than hold it at bay. Thus, for me, organizational leadership and governance at this moment is not about managing what already exists or resignedly treating scarcity and decline as set and insurmountable. Instead, I understand responsibility in uncertain times as looking ahead and opening up ways forward, guided by optimism grounded in reality and in communities' needs, capacities, and ideas — finding and contributing solutions to the advantage of the global commons. It would be my wish for SPNHC's leaders — council, committee chairs, and representatives — and its members, to see solutions and opportunities where others see only effort, cost, and risk, and to bring to the society leadership that is open to change. The opportunities provided by the KM-GBF and SPNHC's community's capacity to act are in place — what is needed now is the courage to seize them.

ENTOMOLOGICAL COLLECTIONS NETWORK (ECN)

ECN (<https://ecnweb.net/>) formed an MOU with SPNHC in late 2016; this is our 10th annual report. ECN is a 501(c)(3) non-profit international organization dedicated to promoting entomological science through the preservation, management, use and development of entomological collections and to disseminating information and fostering communications between collections managers around the world regarding best practices in entomological (and arthropod) natural history collections. The Network is organized and operated exclusively for scientific and educational purposes.

The annual ECN meeting (ECN 2025 08-09 November 2025: <https://ecnweb.net/welcome/meeting/ecn-2024/2025-program/>) was held as a blend of in-person and virtual modalities again in 2025 to facilitate and foster international participation. The in-person venue was the Hyatt Regency Portland at the Oregon Convention Center, Portland, OR, U.S.A. Meetings were held Saturday, 08 November and Sunday, 09 November, 2024. Once again, the "virtual" presentations provided a unique opportunity to hear from colleagues who usually might not otherwise be able to attend the meetings and to "virtually visit" several entomological collections from all over the globe. We had 148 in-person attendees and 42 virtual attendees worldwide, and 34 contributed talks.

SPNHC is an organizational Associate Participant in the Global Biodiversity Information Facility (GBIF: <https://www.gbif.org/>). James Macklin is the current GBIF "Head of Delegation" for SPNHC and also serves as the Canadian Node Manager. The 32nd Annual GBIF Governing Board Meeting took place in Bogotá, Colombia from October 16th -20th in association with the Living Data Conference (<https://livingdata2025.com/>). There were many valuable updates presented on the core work GBIF is currently focused on (<https://docs.gbif.org/2026-work-programme/en/>) in support of the Strategic Framework covering 2023-2027 (<https://www.gbif.org/document/50117Bxn2p1vRgpb7aXaT/gbif-strategic-framework-2023-2027>).

GBIF continues to promote the digitization and mobilization of biodiversity occurrence data and provide support through making available a wide variety of tools, best practices and documentation. In addition, if you have not looked at the country-level information pages, I encourage you to do so as they can be very informative. Numerous opportunities are available for training at various scales as well as competitions for funding to develop new tools and methods for data mobilization, quality control, and dissemination. I encourage all members to get involved and support this critical organization.

Of note, GBIF continues to actively promote the diversification of its new conceptual data model to support richer, more complex types of biodiversity data (<https://www.gbif.org/new-data-model>). They have run several webinars explaining the proposed model including one on implications for collection management systems. GBIF are

currently very interested in feedback on the model based on the use cases they have considered as well as being interested in testing additional ones. Also, if you are interested in having a custom site to showcase your data, you might consider a GBIF-hosted data portal. There are now several portals that have been developed based on regions and themes (<https://www.gbif.org/hosted-portals>). Work also continues on the Global Registry of Scientific Collections or GRSciColl (<https://www.gbif.org/grscicoll>). The main goals are to “improve access to information about scientific collections, their host institutions as well as contacts for key collections and curatorial staff” and “improve interoperability among databases by providing unique codes and machine-readable identifiers for institutions and collections”.

Appendix 1

Proposed changes and amendments to SPNHC Bylaws

Society for the Preservation of Natural History Collections Bylaws

(as revised and approved 1994, 2011, 2017, 2023, 2026)

ARTICLE I. NAME

The name of the organization shall be the Society for the Preservation of Natural History Collections, hereafter referred to as the Society.

ARTICLE II. NATURE

The Society is a multidisciplinary organization, including persons within the fields of anthropology, botany, geology, paleontology, zoology, living collections, and others who are interested in the management, conservation, and preservation of natural history collections. Natural history collections comprise specimens, and supporting analog and digital documentation, such as labels, ledgers, card catalogs, library materials, field data, photographs, audio and video files, X-ray and CT scans, and archives. Preservation refers to any direct or indirect activity providing continued and improved management and care of these collections and supporting documentation.

ARTICLE III. PURPOSE

The purpose of the Society shall be:

- a) to provide for and maintain an international association of persons who study, care for, work with, or are interested in natural history collections;
- b) to encourage studies about the essential requirements for preservation, management, storage, research, and display of natural history collections;
- c) to publish a journal and newsletter as well as encourage the dissemination of information about natural history collections in journals, bulletins, proceedings, and wherever such information is appropriate; and
- d) to hold annual meetings and encourage conferences, symposia, workshops, and other meetings about natural history collections in order to facilitate exchanges of ideas and information.

ARTICLE IV. MEMBERSHIP

Section 1.

Classes of Members. The Society shall consist primarily of seven classes of membership, namely, Regular, Student, Library/Subscription, Institutional/Associate, Corporate/Commercial, Life Members, and Honorary Members (bestowed). Other categories of membership can be added or removed as needed by the Society, with approval of a majority of the Council Members. Unless otherwise stated, membership is by way of application.

Section 2.

Regular, Student, and Life Members. Any individual interested in or concerned about natural history collections is eligible to apply for Membership. Regular Members shall be eligible to vote at Business Meetings of the general membership, vote for Council Members on Society ballots, hold office in the Society and receive Society publications.

Student Members shall enjoy the same rights and privileges as Regular Members. Student membership is available to individuals enrolled in a course of study leading to a degree.

Life Members have elected to pre-pay their membership in the Society in perpetuity and shall enjoy the same privileges as Regular Members.

Section 3.

Library/Subscription Members. University and Institutional libraries shall be eligible to join the Society as Library/Subscription Members. Such Members shall receive only the publications of the Society and they shall not be entitled to voting privileges.

Section 4.

Corporate/Commercial and Institutional/Associate Members. Government departments, corporations, private institutions, and others shall be eligible to join the Society as Corporate/Commercial Members; institutions and organizations whose mission or goals align with the Society shall be eligible to join as Institutional/Associate Members. Such members shall receive the publications of the Society and may appoint a delegate to attend Business Meetings of the general membership.

Corporate/Commercial Members and Institutional/Associate Members, through their delegate, may vote at Business Meetings of the general membership and vote for Council Members on Society ballots. Delegates may not hold office in the Society.

Section 5.

Honorary Members. Council may elect Honorary Members in recognition of outstanding contributions to natural history collections or to the Society. Honorary Members have all the rights and privileges of Regular Members.

Section 6.

Dues and Assessments. Council shall set annual dues and special assessments to the members according to the needs of the Society. The membership year shall be the calendar year, and dues shall be payable in advance. Honorary Members shall not be billed for annual dues or other assessments. Failure to pay dues will result in loss of membership, but membership may be reinstated for the years that dues are paid.

Section 7.

Removal of Membership. Any member who conducts activities counter to the objectives of the Society and in a manner

viewed as unacceptable by members of the Council, may have his/her membership revoked by two-thirds vote of the Council. Reinstatement may be provided by a simple majority vote of the Council members after supporting information has been presented.

Section 8.

Voluntary Membership Withdrawal. Any member may voluntarily withdraw from membership by delivering a written resignation to the President.

ARTICLE V. MEETINGS

Section 1.

Annual Business Meeting. The Society membership shall meet annually or at such place and time as the Council shall resolve. A Council Meeting of officers, committee chairs, society representatives and Members-at-large, and a Business Meeting of the general membership, shall be held during the annual meeting of the general membership. The general membership can request that Council call special meetings of the Society by submitting a written requisition signed by at least 20% of the voting members.

Section 2.

Conduct of Business. Business of the Society shall be transacted at Annual or Special Business Meetings of the general membership. Conduct of the meeting shall adhere to “Robert’s Rules of Order” in all cases to which they are applicable, and in which they are not inconsistent with the bylaws or other rules adopted by the Society. Every resolution shall be determined by a majority of voting members present, unless specifically provided by statute or these Bylaws.

Section 3.

Notice of Meetings. Members shall be given written notice of Annual or Special Business Meetings of the general membership by sending a written notice to each member by mailing to each stating the place, day, and hour of the meeting and, in case of a special meeting, the purpose for which the meeting is called, and give sufficient information to members about such meetings to allow them to form a reasoned judgment on any decision to be taken. Notice of Special Business Meetings of the general membership shall be sent mailed not less than ten working days before the date of the meeting.

Written notice of the next Annual Business Meeting of the general membership is to be given no later than ten working ~~six~~ days before the date of the meeting.

Section 4.

Quorum. A quorum for transaction of business at Business Meetings of the attending general membership shall be voting members representing not less than 5% of the total number of voting members in good standing.

Section 5.

Voting and Representation. Each Regular, Student, Honorary, Life Member, and Corporate/Commercial and Institutional/Associate delegate in good standing and present shall be entitled to one vote on each issue at Business Meetings of the general membership.

ARTICLE VI. OFFICERS**Section 1.**

Executive Officers. The executive officers shall be the President, the Past- President, the President-Elect, the Secretary, the Treasurer, the Managing Editor, and the Membership Committee Chair. Executive officers are required to be Regular, Honorary or Life Members in good standing.

Section 2.

Presidential Officers. The President shall be the chief executive officer of the Society, shall preside at meetings of Council and Business Meetings of the general membership, shall be responsible for executing policies determined by Council, shall act as spokesperson for the Society, and shall see that all orders and resolutions of Council are carried into effect.

The Past-President and the President-Elect shall assist the President, shall be members of Council, and shall substitute for the President when necessary. The President-Elect shall be elected by a plurality of votes cast by voting members of the Society.

Section 3.

The Secretary. The Secretary shall assist the President, shall answer all general correspondence directed to the Society, and shall be responsible for the minutes of all meetings of Council and the Business Meeting of the general membership. The Secretary shall be elected by a plurality of votes cast by the voting members of the Society.

Section 4.

The Treasurer. The Treasurer shall be responsible for all monies and valuable effects in the name and to the credit of the Society, for full and accurate accounting of receipts and disbursements in books belonging to the Society, and for maintaining a current list of members. The Treasurer shall have signatory powers and shall disburse the funds of the Society as may be ordered by Council. The Treasurer shall render to the President and Council at the Annual Business Meetings of the general membership, or when Council so requires, an account of the financial transactions and status of the Society. The Treasurer shall be elected by a plurality of votes cast by the voting members of the Society. ~~be appointed by the President with the approval of a majority of the Council Members.~~

Section 5.

The Managing Editor of the Society's Journal. The Managing Editor of the Society's publications shall be responsible for obtaining reviews, selecting and editing copy, layout, printing, distribution, and any other functions necessary to get material to the members in a timely fashion. ~~The Managing Editor shall be appointed by the President with the approval of a majority~~

~~of the Council Members. The Managing Editor shall be elected by a plurality of votes cast by the voting members of the Society.~~

Section 6.

The Membership Committee Chair. The Chair of the Membership Committee shall be responsible for activities that promote the growth, retention, and diversity of the membership. ~~The Membership Committee Chair shall be appointed by the President with the approval of a majority of the Council Members. The Managing Editor shall be elected by a plurality of votes cast by the voting members of the Society.~~

Section 7.

Nomination of Officers. A slate of candidates for office shall be prepared annually by an Elections Committee appointed by Council. Candidates may be proposed in writing by Regular, Student, Life or Honorary Members in good standing. The committee shall present a slate with a minimum of one name for each position and with due regard to the proposals received. Elections of officers shall be carried out in accordance with the Leadership Manual, prior to the Annual Business Meeting of the general membership and the officers elected with take office from the start of the calendar year (1 January) following the election at that meeting. Both the ballot and the responding votes of the entitled members shall be transmitted via appropriate communications media approved by Council. Regular, Student, Honorary, and Life Members and delegates of Corporate/Commercial Members and Institutional/Associate Members may vote for officers. The President shall be responsible for overseeing the elections and communicating the results of the election.

Section 8.

Vacancies. Should the office of the President become vacant, the President-Elect shall become President. The President-Elect will complete the term of the President as well as the regular term of President for which the individual was elected.

Should the office of President-Elect become vacant, Council shall by majority vote elect a Council Member to serve in an interim capacity until a replacement can be elected by the general membership, thus the following election may include candidates for the office of President-Elect and President.

Should the office of Past-President become vacant, it will not be filled. Should the office of Secretary become vacant, the President shall appoint a Regular, Honorary or Life Member in good standing to serve as interim Secretary with the approval of a majority of the Council Members, until a replacement can be elected.

Should the office of Treasurer, Membership Chair, or Managing Editor become vacant, the President shall appoint new interim officers with the approval of a majority of the Council Members, until the next election cycle.

Section 9.

Removal from Office. An officer who is found to carry out the duties of office in a manner counter to the interests of the Society may be removed from office by a secret ballot vote expressing a consensus of two-thirds of all Council Members, or by a majority vote of the membership ~~taken at an Annual Business Meeting of the general membership or any special meeting of the membership called for that purpose.~~

Section 10.

Term of Service of Officers. Each presidential office shall be filled by the same individual for no more than a two-year term, except when the President-Elect must prematurely assume the office of President. The Secretary and Treasurer shall be elected for a two-year term, repeatable consecutively up to three ~~unlimited~~ times. The ~~Treasurer~~ Membership Chair and the Managing Editor shall be elected ~~appointed~~ for a two-year term, repeatable consecutively unlimited times.

ARTICLE VII. COUNCIL**Section 1.**

Council. The Society's affairs shall be conducted through a Council consisting of the following members: the Executive Officers plus six Members-at-large. All members of Council shall be entitled to one vote each. All members of Council will act without remuneration.

Section 2.

Quorum. A quorum of Council shall consist of two-thirds of the Council Members.

Section 3.

Meetings. Council shall meet at the Annual Meeting of the general membership and at other times ~~and places as it deems necessary.~~ Council decisions are determined by a simple majority of voting Council Members present. ~~When all Council Members consent, a Council Member may be deemed to be in attendance when communications equipment can be used to allow all persons participating in the meeting to hear all other participants.~~

Between ~~regular~~ meetings of Council, the President or, on request, the Secretary, shall send to each Council Member pertinent information about matters of concern. Council may discuss and vote via appropriate communications medium on matters deemed by the President to require immediate action.

Section 4.

Election of Members-at-large. The Members-at-large shall be elected by a simple plurality of votes of the voting members of the Society. All vacancies in Member-at-large positions shall be filled on an interim basis by Presidential appointment of a Regular, Student, Honorary or Life Member in good standing.

Section 5.

Nomination of Members-at-large. Candidates for Member-at-large positions shall consist of Regular, Student, Honorary or Life Members in good standing. Elections shall be carried out by the same procedure as for the election of officers. The members that are selected will take office from the start of the calendar year (1 January) at the Annual Business Meeting of the general membership following the election.

Section 6.

Term of Office. Each year, two Members-at-large shall be elected for a three-year term.

Section 7.

Removal from Office. A Member-at-large who is found to carry out the duties of office in a manner counter to the interests of the Society may be removed from office by a secret ballot vote expressing a consensus of two-thirds of all Council Members, or by a majority vote of the membership taken at the Annual Business Meeting of the general membership or any special meeting of the membership called for that purpose.

Section 8.

Execution of Documents. Contracts, documents, or instruments in writing requiring the signature of the Society shall be signed by the President or the Treasurer. The Council may by resolution, appoint an officer or officers, on behalf of the Society, to sign specific contracts, documents, and instruments in writing.

ARTICLE VIII. COMMITTEES**Section 1.**

Committees Appointed by Council. Council may appoint Standing Committees for special purposes and designate their duties and powers in the resolution of appointment. Such resolutions must be adopted by a majority of the Council Members. The chair positions and members of Standing Committees are appointed on an annual basis by the President. Unless individual exceptions are approved by a majority of the Council Members, only members in good standing are permitted to serve on committees of the Society.

Section 2.

Committees Appointed by the President. The President may appoint Sessional Committees and designate function, chairpersons, and members. Unless reappointed by the incoming President, such Sessional Committees shall cease to function upon the conclusion of the term of the President who appointed them.

ARTICLE IX. FISCAL YEAR**Section 1.**

The fiscal year of the Society shall be the calendar year commencing on the first day of January and ending on the 31st day of the following December.

Section 2.

Every year Council shall appoint an external auditor to audit the accounts of the Society.

Section 3.

The audited accounts will be made available to Council at least thirty days prior to the Annual Business Meeting of the general membership.

ARTICLE X. AMENDMENTS

On resolution by majority of the Council, or by written proposal signed by not less than two-thirds of the members in good standing, these Bylaws may be amended or repealed by a simple majority vote of the members in good standing at the Annual Business Meeting of the general membership or a special meeting called for the purpose. Written notice of the substance of the proposed amendment is to be sent to all members not less than thirty days prior to the time at which it shall be submitted to a vote.

Changes in the Bylaws shall go into effect following their adoption ~~at the Annual Business Meeting of the general membership.~~

ARTICLE XI. SEAL**Section 1.**

The Society shall have an official seal which shall contain the words “Society for the Preservation of Natural History Collections-1986”.

Section 2.

The Seal shall be placed in the custody of the Treasurer or other Executive Officer as designated by the President.

ARTICLE XII. DISSOLUTION OF SOCIETY

Any proposal for the dissolution of the Society must be sent to each member not less than ninety days prior to the vote. A decision in favor of dissolution requires a two-thirds vote of the total voting membership.

Upon the dissolution of the Society, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.
